Dear Members of the Council.

Because I will be out of town on May 24 and will be unable to attend the town council hearing on the potential of renaming Airport Road, I would like for these comments to be updated and made known to you. They reflect in large part a note I sent to you a few mouths ago.

Your consideration of the proposal for renaming Airport Road was an excellent provocation for me to think about it. As I have thought about it and heard from others, I believe that it would be understandable, but misguided to rename a Chapel Hill thoroughfare for Dr. Martin Luther King.

Working at WCHL caused all of us here to be involved in the "recognition business" over the years, so your proposal brought to the foreground some thoughts about how local agencies, like the Town, should use local recognition opportunities, like the naming of things.

It has led me to these two suggestions. First, as a matter of town policy, I believe that your idea should provoke us to think more aggressively of local figures who should be appropriately honored. If we wish to recognize coungeous and effective pioneers in civil rights, I believe we are overdue in a major recognition of Howard Lee, our first black mayor.

Mayor Lee transformed Chapel Hill politics in ways that, to this day, affects the makeup and philosophy of town government and community values. There will never be a Howard Lee Road in Washington, D. C., so if he is to be recognized for his contribution to us, it should be us, in our town, and while he is still alive.

We can also make an equally strong case for Bob Seymour or Rebecca Clark. I am sure there are others in that realm. But, with great respect for Edith Wiggins who first proposed this during the season of the already existing national holiday for Dr. King, but I truly believe the proposal is wonderfully well-intentioned but misguided.

While we are at it, we already have a wonderful recognition for Chris Fordham in Fordham Boulevard. Yet, we do not have a Hardin Road. Chancellor Paul Hardin did more to promote town gown relationships, partnerships and progress than any chancellor in the last fifty years. At a time of current tension between town and gown, a recognition of the former Chancellor who did so much would do much today to send a signal of our appreciation for the value of our relationship with UNC.

Generally speaking, WCHL's policy has always been to leave national messages and recognitions to national media, so that we could use all our energies and resources to support local messages and recognitions. I believe that would be a good general policy for the Town.

I see hopeful that, in the areas I have discussed here, the council should have an assertive policy of initiating a periodic, perhaps annual, review of all those who should be so honored, relying less on response to outside requests.

I hope you find this suggestion helpful.





I WAS A BUSINESS MAN IN CHAPEL HILL FOR THIRTY YEARS AND I KNOW FROM EXPERIENCE IF THE MATERIALS COST A CERTAIN AMOUNT THE LABOR COST IS ALMOST EQUAL . IT COSTS MANY HOURS OF WORK AND MANY TAX PAYERS DOLLARS.

WHAT ALSO DISTURBED ME WAS, THE NEXT DAY IN THE CHAPEL HILL NEWSPAPER THE TOWN MANAGER SAID WE NEED TO RAISE TAXES AGAIN BECAUSE THE TOWN NEEDS MORE MONEY. WE HAVE A BEAUTIFUL LIBRARY IN CHAPEL HILL WHERE BOTH BLACK AND WHITE GO TO FURTHER THEIR KNOWLEDGE THAT WOULD MAKE A GREAT MONUMENT. WE HAVE A NEW AND BEAUTIFUL HOMESTEAD PARK WHERE CHILDREN AND ADULTS OF ALL RACES GO TO PLAY SOCCER, BASEBALL AND SOFT BALL WALK THE TRAILS, AND HAVE PICNICS UNDER THE TREES.

IS THIS NOT MORE IN KEEPING OF THE VISION OF DR. KING RATHER THAN A STREET THAT DOES NOTHING MORE THAN ASSIST TO FROM POINT A TO POINT B AND ADDS TO OUR AIR POLLUTION.

I SINCERELY HOPE THAT WHEN THE COUNCIL MEETS TO DISCUSS THIS AGENDA THEY WILL GIVE IT FULL THOUGHT AND CONSIDER THE FEELINGS AND CONCERNS OF THE MANY AND NOT JUST THE FEW WHO ARE ADVOCATING THE CHANGE MOST OF WHO DO NOT LIVE IN THE TOWN OF CHAPEL HILL.

Good evening, my name is Charles Carver, and I am a business owner on Airport Road. I am a CPA with a staff that has ranged from 5 to 15 persons with approximately 1500 clients coming and going during the year from my business on Airport Road.

Growing up in Roxboro in the 40's & 50's never would I have imagined that I would have a black son-in-law, whom I love and admire as my own son & to be also praying to become the grandfather of a bi-racial adopted child. Without Dr. King and his work, which I admire, my family literally would not be what it is today. I am many things, but racist is not one of them. One of the things I am is a small business owner.

In my own business this name change will probably cost me in excess of \$5,000 in out of pocket expenses. This involves changing my own signs, my letterhead, my website, my billing, my telephone listing, ect... I have also recently spent several hundred dollars with the Chamber of Commerce for these new updated maps. Many other people also contributed to this venture. I am in total disagreement with the lady that said, "It doesn't matter what it cost".

Along the same line, clients that I have trained for years, many of which are out of state will continue to use Airport Road. While the post office will forward mail for 1 year this will not help with the tax payer information that continues to arrive several years later. I do not want to imagine the problems that may occur because of returned mail. Problems for both my clients & myself. Professional malpractice is not something I want to entertain. These problems are there for other professions as well ie: Legal, Medical, Dental, Optical, Insurance, Real Estate and the list goes on.

I admire the work of Dr. King without which we would still be in the throws of Jim Crow Laws. I wholeheartedly agree that we should continue to honor the work of Dr. King. However another piece of pavement does not fit the bill. Airport Road should remain Airport Road.

I also encourage council not to take action due to the estimated \$60,000 cost to the town of Chapel Hill as well as to the business owners as mentioned earlier. We have heard a cost figure of

\$16,000 for signs, but that is only the surface and does not include all the underlying expense to make such a change ie: installations, maps, and the police department, ect...

What might be a better way to honor Dr King's work? We are constantly acquiring new and needed facilities that were important to him, ie: libraries, schools, renovated town hall, ect... Dedicate one of these new projects to him and use the dollars we have in a more humanitarian way.

Please listen to the citizens of Chapel Hill on this issue. Review the notebooks that you have been provided. Note the hundreds of signatures. Do not divided Chapel Hill on this issue. I would ask that the council find a way to honor Dr. King's work, a way in which all of the citizens can rally behind and be proud of.
