Message from Administration



Dear Members, Happy new year!

Thank you all for your generous donations, volunteering efforts and approval of constitution amendment. 2017 started with finishing up Learning Center construction and paying off construction bills of more than \$500K. Year ended with entertaining Gala night that generated ~\$50K funds. Learning Center usage has ramped up very nicely in just 7 months of operations. We have reached the annual revenue of \$1.0M in 2017 by exercising fiscal discipline and increasing facility usage. Financial details are provided in this newsletter.

2018 has started with approval of Constitution Amendment that now provides us robust operating bylaws. HSNC is now poised for another breakout growth phase, with larger community in triangle. In last 18 years, HSNC has added two multi-purpose facilities, Main Hall and Learning Center. Thanks to volunteers, members and community in helping build those. That brings us to what's next? HSNC temple is 30 years old, and needs expansion as well as significant improvements. Devotees strongly desire a nice temple with Shikhar. Having majority of building investment in Main Hall and Learning Center, it's time now to focus our efforts and funds to Temple and overall campus. Our Campus Development Committee will be led by Trustees, and it has already kicked off planning of next phase of HSNC Campus, and will reach out to seek community input in the process.

We would like thank directors Gaurang Shah, Sunil Jain, Shashi Mailk and Prasad Satghare for their services in 2016 and 2017. In the beginning of 2017, BOD promised good governance and transparency in communication. We have regularly published minutes of all BOD meetings of 2017, on web site at https://www.hsnconline.org/bodmeetings/. Thanks to Aman Gupta for his services as HSNC secretary in 2017.

This year would like to explore the possibility of different religious groups or regional groups associated with HSNC, sponsor temple, main hall, LC and other areas of HSNC campus for regular cleaning and keeping them in clean condition. Spiritual Corner

Bhakti (Devotion) and Bhagavad Gita

An ocean of literature on Bhakti is available in the great Epics of Ramayana and Mahabharata and in Bhagvatham and Puranas. There is no equivalent English word to describe Bhakti which is often understood as Love or Devotion. Bhakti represents unselfish giving without looking for any return favor. It is also self-surrender to the source of love or the higher SELF. Whenever, we bow to God, we do Namaskaram. Na-mama-kara declares that "all that I am and have is due to Your Grace." During our temple worship the term "Namah" is invariably used. The Taittiriya- Upanishad acclaims the virtue of using "Namah" while worshiping and says; tam Nama ityupAsIta, namyante-asmai kAmAh (Desires fall at the feet of such a one who worships Him). Every action with Bhakti is done to serve the beloved one. Sankara defines Bhakti as the contemplative living in one's natural state (stateless state) with the divine. In the divine state we can view every other being in the world with equanimity. Every being in the world will become the mirror reflection of the Paramathma (SELF) which is connected as - "The, I within you will see the, you within me."

This divine state can't be attained through studies or scholarship. It can only be accomplished internally without an iota of external influence! It is the divine perception of equanimity that sprouts forth with the Divine Grace. Bhakti enables one to recognize the necessity to surrender the possessive ego permanently. The Ego consists of two illusions - the first, ownership to wealth and knowledge and the second - ownership of control over other beings. The human intellect can recognize the fact that "at the time of birth, we came to this world with zero possessions and we will leave this world without any possession." It seems that our illusionary behavior is due to our total ignorance of zero possessions! By surrendering the ego, the devotee (Bhakta) gives up the illusory behavior and retains the True Human Nature with the Divine qualities. True Bhakti can see the godliness of infinite love through the total surrender of ego. The Bhakta and the universe become internal and external perceptions disappear with the experience of Bliss!

Bhakti according to Vaishnavam consists of Nava Vidham (nine forms): "Sravanam Keerthanam Vishnoo; Smaranam Pada Sevanam; Archanam Vandhanam Dhasyam and Sakyam Athma Nivedhanam. These nine forms of Bhakti are: 1.Sravanam – Listen 2.Keerthanam – Recitation 3.Smaranam – Think and Remember 4.Pada Sevanam – Surrender and Serve 5.Archanam – Worship and Prayer 6.Vandhanam – Namaskaram 7.Dhasyam – Dutiful with Total Dedication 8.Sakyam – Friendly Attitude 9. Athma Nivedhanam – Total Surrender of Ego.

Ramakrishna Paramahamsa gave this beautiful example to illustrate Hanuman's Dashya Bhakti towards Shri Ram. Lord Ram once asked Hanuman, "What is your attitude toward me? How do you look upon, think of and worship me?"

Hanuman replied, "O Rama, I am conscious of my body when I feel that I am this visible body and then I have the conviction that thou art the Lord and I am thy servant. Thou art to be served and I am the one to serve.

When I am conscious of myself as the individual self, one with the mind, the intellect and the soul, I have the conviction that thou art the whole and I am thy part.

Again When I remain in Samadhi (in the mood that I am the pure Self without all qualifying adjuncts) I have the conviction that I am also verily that which Thou art. Thou and I are one. There is no difference whatsoever."

The essence of Bhakti is explained in Bhagavad Gita through verses 13 to 20 of Chapter 12. According to Lord Krishna, the ideal devotee (Bhakta) should take efforts to attain the following virtues: (1) No hatred toward any living being (2) Cultivate friendship and compassion (3) Give up the feeling of "I" and "Mine" (4) Unmoved by hap-

piness and misery (5) Be forgiving (6) Be steadfast in mind with self-control (7) Always feel content and self-sufficient (8) Have strong determination (Vairagya) (9) Surrender the mind and intellect to God (10) Get strong will power to get rid of fear (11) Divert the desires toward God (12) Keep mind and body pure (13) Don't indulge in idle talk (14) Avoid the feeling of elation, enmity and desire (15) Act self-reliantly without pressure (16) Keep stable mind to accept plurality of pain and pleasure, friends and foes, honor and disgrace and good and bad. The seed of Bhakti needs to be nourished with Vinaya (discipline), Shraddha (faith with determination) and Vairagya (detachment and serenity) to mature to become Vivekam (wisdom).

In Bhagavad Gita Chapter 9 verses 26 and 27 Lord Krishna states what is expected from a Devotee: "Whoever offers Me even a leaf, a flower, a fruit or a little water with a pure mind with devotion, I accept as devotion;" and "All that you do, eat, give away, as well as all austerities that you perform - Do it as an offering unto Me." We at the elementary stage of spiritual evolution and by recognizing that Faith is an Integral part of Bhakti we should take efforts to discipline the unsteady mind from the pitfalls of desire, hate, lust and greed. Most importantly we need the wisdom to **Do What Rama did and Krishna Said!**

Second Amended and Restated Constitution and Bylaws of The Hindu Society of North Carolina

Constitution Amendment vote counting was done on Friday, January 19, 2018, in temple. Following are the vote count details.

Total Ballots mailed to the members: 2721

Total Ballots received back from the members: 1516 (55.71 %)

Total "Yes" votes: 1366 (90.10% of received)

Total "No" votes: 126 (8.31%)

Invalid ballots: 24 (1.58%)

Board Resolution: Based on the results of Constitution amendment votes counting, **Members have** approved the "Second Amended and Restated Constitution and Bylaws of The Hindu Society of North Carolina". This constitution becomes effective as of January 20, 2018.

Immediate Adjustments required as per amended Constitution

- 2 additional BOD positions (total 9), are required to be filled. Election notification is published on website, sent out via email and also included in this newsletter.
- Directors position filled in as per new constitution shall hold office for three (3) years. No Director
 may serve consecutive terms on the BOD. The spouse of any Director or Trustee cannot simultaneously serve as a Director or Trustee.
- Only two types of Memberships going forward: Life Membership with \$600 dues, and Annual (calendar year) Membership with \$100 dues.
- Membership that required to pay \$25 every year is no longer being offered. Those who are on that type of membership will continue to be member as long as they pay \$25 every year before January 31, and there is no previous break in payments.
- New official positions of BOT Chair, Co-Chair and BOT Secretary are created.
- Some new members (required to change) of Election Committee, Grievance Committee, Membership Committee, and Policy Manual Committee, are now nominated by both BOD and BOT.
- Planning is underway for separation of Savings (incoming funds) and Checking (operating) accounts.
- All new long term contracts and land leasing or sale contracts shall be required to be approved by both BOD and BOT.

Election processes 2017 and the amendments approved in 2018 will be followed in conducting the elections. In case of any conflict, requirements set forth in the newly approved <u>"Second Amended and Restated Constitution and Bylaws of HSNC"</u> will supersede. The dates mentioned in existing election process 2017 are to be adjusted according to the timing of this byelection.

Note: Excerpts from Article 4.2 of the Second Amended and Restated Constitution of the Hindu Society of North Carolina, that became effective on Jan 20, 2018.

Each Director shall be required to be a Member of the Society during his or her term of office and for at least the three (3) consecutive full calendar years immediately prior to the beginning of such Director's term of office. A director's primary residence shall be within a one (1) hour drive of the Society's principal office. A director shall not have any criminal conviction other than minor traffic incidents such as speeding tickets or parking tickets.

A Member may not simultaneously serve on both the BOD and BOT. No director may serve consecutive terms on the BOD.

The spouse of any Director or Trustee cannot simultaneously serve as a Director or Trustee.


