Constitution Amendment Information Session for Members at 4:00-6:00PM on Sunday, October 15 in Learning Center room #1 and #2

As you all know, Directors and Trustees have undertaken an important task of Constitution Amendment for last three months. BoD and BoT are actively engaged with the constitution committee appointed in earlier this year and headed by Dr. Ram Chandran (chair), Dr. Subhash Chandra (co-chair) and Dr. Jalyan Parikh (co-chair) along with several long term veteran volunteers of society. The Committee has met 15 times during May, June and July 2017 and discussed various available options for consideration. The merits of the proposed changes have been thoroughly debated to arrive at a proposal that is best for the better governance of HSNC. The initial draft of the amendment is aimed to achieve the following high level objectives.

Key Changes Proposed in the revision of the Constitution:

- Provide clarity on Directors and Trustee roles and responsibilities. Integration of Article 4A (Trustee amendment) into main article 4
- Improve stability of the Critical Committees by longer tenure with staggered changes in members
- Add checks and balances in important areas like finance, elections, grievances, dispute resolution, internal audit, and campus development
- Increase number of directors to nine with longer, 3 year term.
- Add Mediation and Arbitration Panel as internal Arbitration process or mandate for any grievance and disputes prior to pursuing legal actions
- Simplify membership to annual and yearly with minimal dues and membership categories for recognition based on lifetime contribution
- Shared Financial Control by Directors and Trustees.
- Protection of Real Estate and Digital Assets.

Constitution committee has the draft of the amendment almost ready to send for voting by the general membership.

Constitution committee will hold an Information session for Members to hear about the amendment and provide input at **4:00-6:00PM on Sunday, October 15, in Learning Center room #1 and 2.**

Note: Excerpt from Article 4.2 and 4A.6 of the Amended and Restated Constitution of the Hindu Society of North Carolina.

Each Director shall be required to be a Member of the Society during his or her term of office and for the two (2) consecutive full calendar years immediately prior to the beginning of such Director's term of office.

Each Trustee shall be required to have served at least one (1) full two year term as Board of Director and be a Member of the Society during his or her term of office and for the two (2) consecutive full calendar years immediately prior to the beginning of such Trustees term of office.



Report from HSNC Campus Development Committee (CDC)

Construction on the new Learning Center is complete. It will enhance the ability of the HSNC to respond to the needs of our community. Our community, and its needs, have grown at a very rapid pace. It is essential that we understand the long-term needs of our community and take proactive steps to shape and develop the HSNC campus to address the current and future needs.

The Campus Development Committee (CDC) with a representation from both BOT and BOD and subject matter experts will be responsible for the development and renovation of the HSNC campus grounds and buildings. Its responsibilities will include:

- Review previous studies and planning activities to prepare, for discussion purposes, an initial list of programs (campus activity list) and potential long-term improvements (architect-programs). Review with BOT and BOD and seek comments and suggestions.
- Based on input from the BOD and BOT, other committees, and the membership, use in-house expertise and volunteers to develop a Preliminary Campus Plan that shapes the long term "vision" of the HSNC. Present to BOD and BOT and membership for comments/feedback. Refine Plan and recommend adoption of the plan.
- Request permission/funding for refinement and finalization by a professional firm. If appropriate, submit to Town of Morrisville.
- Recommend actions, policies, and procedures for the implementation of the plan, including, but not limited to, property acquisition, zoning/rezoning, new construction, renovation/repurposing of existing buildings, relationships with affiliated groups, enhancement of campus grounds, traffic policies, etc.
- Periodically review and update the campus plan. Revise policies and procedures, as appropriate.
- The CDCs responsibilities will not include operation, rental, routine maintenance and upkeep of the buildings.
- Due to the long-term nature of its duties (re-zoning, town approval process, etc.), the Intent is for the CDC to be a standing committee that goes beyond current year for continuity.

The CDC will discharge its responsibilities and conduct its business in a professional manner using transparent and consensus based procedures.

The CDC includes individuals with knowledge and expertise in diverse fields pertinent to its mission. These individuals volunteer their time and efforts in the service of our community. At this time, we need volunteers with expertise in the following fields to serve as advisors or members of the committee. Interested individuals should contact the committee chair, Ish Sud.

Significance of Annakut

Govardhan puja, also called Annakut (literally meaning "mountain of food"), celebration has been carried from over 5000 years ago (in the time of Lord Krishna) till today. The tradition started when Lord Krishna told the people of Vrindavan dham to start worshipping the Govardhan mountain instead of Lord Indra because Indra had become too proud of himself and because the Govardhan mountain selflessly provided lands for the cows to graze and brought rains down to the fields.

Upon learning about this Lord Indra got angry and started pouring heavy rains on Vrindavan. Lord Krishna sheltered everyone by raising the mountain on his little finger and not harm came to anyone in Vrindavan. Seeing this, Indra Dev realized his mistake and asked forgiveness from Lord Krishna. After 7 days, Lord Krishna lowered the mountain and asked the public of Vrindavan to worship Govardhan and have Annakut every year. Since then, Govardhan festival is celebrated on this day. In addition, in many parts of India, this is also the beginning of the year according to the Vikram Samvat calendar.
