I. BACKGROUND

- (1) On February 7, 2011 at 6:02 p.m., Plaintiffs Adam J. Horowitz, Leah Josephson, Christopher B. Lane, and Chelsea Cook filed a Complaint asking this Court to enjoin the Board of Elections from allowing the UCommons referendum to appear on the February 8, 2011 ballot. Alternatively, Plaintiffs' requested the Court to enjoin the Board of Elections from certifying and releasing the results of the UCommons referendum on grounds that the Union campaign in support of the passage of the referendum violated numerous election laws under Title VI of the Student Code. *See* VI S.G.C. §§ 404(B), 405(F), 405(G), 406(I)(1), and 406(J); *see also* Complaint of Horowitz et al., *Horowitz et al. v. Medlin and Phillips*, 10 SSC 002, (2011). Additionally, Plaintiffs contended that both Student Body President Hogan Medlin and Board of Elections Chairperson Andrew Phillips failed in their respective duties to address these alleged campaign violations, as required by duties charged to them by the Student Code in I S.G.C. § 4 and VI S.G.C. § 314, respectively. *Id.*
- (2) On Thursday, February 17, 2011, Plaintiffs notified this Court of their intent to dismiss voluntarily their complaint against Defendant Phillips and the Board of Elections. *See* Withdrawal of Complaint as to Defendant Phillips, *Horowitz et al. v. Medlin and Phillips*, 10 SSC 002, (2011).
- (3) On Friday, February 20, 2011, Plaintiffs notified this Court of their intent to dismiss voluntarily their complaint against Defendant Medlin. *See* Withdrawal of Complaint as to Defendant Medlin, *Horowitz et al. v. Medlin and Phillips*, 10 SSC 002, (2011).

II. ORDER

ACCORDINGLY,

Plaintiffs' voluntary request to dismiss their complaint against Defendant Medlin is hereby GRANTED, and

10 SSC 002 is hereby DISMISSED.
