

EDITORIAL POLICY



ROWAN COUNTY by J.R. (Jethro Rumple) from the CAROLINA WATCHMAN February 5. 1880

Transcribed by Susan Goodman Sides

THE FIRST COURT

As stated on a former page, it is not certainly known where the first court was held. But from the records in the office of the Superior Court Clerk in Salisbury, it appears probable that it was held in June, 1753, only a few months after the county was established. The names of the justices who presided at the courts the first year, were Walter Carruth, Thomas Lovelatty, James Carter, John Brandon, Alexander Cathey, Squire Boone, Thomas Cook, Thomas Potts, Geo. Smith, Andrew Allison, John Hanby, Alexander Osborne, James Tate, and John Brevard. We know, or have some reasons for conjecturing, the neighborhoods from which several of these magistrates came. Walter Carruth owned lands, and probably resided, on the east side of Coddle creek, adjoining the McKnights, in the Prospect neighborhood. James Carter owned the lands in the southeast guarter of Salisbury, on both sides of water Street, and on towards Crane creek, now called Town creek, and probably lived in the present corporate limits of Salisbury. John Brandon lived six miles south of Salisbury, near the Concord Road, on the plantation now owned by Charles H. McKenzie, Esq. Alexander Cathey lived on Cathey's Creek, near Thyatira Church, and was the ancestor of the late Alexander Long, M.D. of Salisbury. Squire Boone lived on the Yadkin, at Alleman's or Boone's ford, and was the father of the great hunger and pioneer, Daniel Boone, of Kentucky. At this place young Daniel spent the days of his boyhood, and no doubt often hunted over the hills and through the thickets of the Yadkin. Thomas Pott probably lived in the Jersey settlement, where Potts' Creek running into the Yadkin River just below the site of the Indian Town of Sapona, perpetuates his name. George Smith was probably from the same neighborhood, where a prominent family of that name still resides. Andrew Allison owned large tracts of land on Fourth Creek, a few miles from Statesville, where a large and influential family of that same may still be found. Alexander Osborne lived on the had waters of Rocky River, about two miles north of Davidson College. He was a leading man in the country, a colonel, the father of Adlai Osborne, and the ancestor of the late eloquent and popular Judge James W. Osborne, of Mecklenburg. John Brevard was probably from the same neighborhood, a little farther west, and not far from Beatties's Ford, on the Catawba. At least this was the neighborhood of the Brevards, one of whom, Dr. Ephraim Brevard, is reputed to be the composer of the celebrated Mecklenburg Declaration of Independence. Of Lovelatty, Cook, Hanby, and Tate, the writer has no knowledge, though doubtless some of their descendants may be still residing among us. There is a ford on the Catawba, and a Post Office in Caldwell county called "Lovelady." Perhaps a remembrance of Justice Lovelatty, of the Rowan County court.

A good part of the time of the first court was taken up in registering the marks and brands which the citizens had invented to distinguish their cattle, and other livestock; and the changes are rung on "crops," "half crops," "slits" and "swallow-forks," in the "off" and "near" ear, and other quaint devices for marking. The cattle that were to be identified by the marks and brands registered in the Rowan Court, ranged over the meadows and prairies of the Yadkin, the Catawba, the Deep, the Saxapahaw, and the Dan rivers. Constables were also appointed whose beats lay as much as a hundred miles from the seat of justice. These old "Records" of the Rowan Court of Pleas and Quarter Sessions, for 1753 '4 '5 '6 are full of interest to any one who will take the trouble to decipher them. For instance, here is a list of constables and their beats for 1753. Preston Goforth of the South Fork of the Catawba. (This was for the region from Hickory to Lincoln.) John McGuire, south side of the Yadkin; John Attaway (?) for Dan River. John Robinson for south side of Yadkin, from the mouth of Grant's Creek to the ford of the same; thence across to the Trading Path; thence along said Path, as far as Coldwater, thence with his Lordship's Line." This shows that the Trading Path ran to the point where Coldwater Creek runs from Rowan into Cabarrus. "John Nesbit had his beat from James Cathey's Creek to the western Path, as far as the fork of said Path. James Howard from James Cathey's Creek to Third Creek, and as far as the Division Ridge between the two settlements. Benjamin Winslow, as far as the Catawba River, and along the King's Line, and Lamb's mill, and down as far as Wm. McKnights. John Doller on Abbott's Creek, as far as the Western Path. David Stewart on the north side of Yadkin, from Muddy Creek and upward. William Fisher for the district included in the Forks of Yadkin. James Watkins from the Orange line as far as Beaver Island Creek, on Dan River. James Hampton from Beaver Island Creek and upwards" (i.e. higher up the Dan.) These names of men and localities show the extent of the jurisdiction of the Rowan Court, stretching from the Orange line and Dan River, to the King's line, and as far west as the south fork of the Catawba, northwest of Lincolnton. The following were the officers of the county, viz: Richard Hilliar, Deputy Attorney General; John Dunn, Court Clerk; James Carter, Esq., County Register; John Whitsett; County Treasurer; Francis Corbin, Esq., Colonel of Rowan Regiment of Foot; Scotton Davis, Captain in Corbin's Regiment.

The following persons are named as composing the Grand and Pettit Juries of the first Court, viz: Henry Hughey, John McCulloch, James Hill, John Barnett, Samuel Bryant, John McDowell, James Lambath, Henry Dowland, Morgan Bryan, William Sherrill, William Morrison, William Linvil.

Samuel Baker asked this Court (1753) to declare his mill on Davidson's Creek (near Centre Church) a public mill, and his request was granted. Jno, Baker proved before this Court that his ear had been bitten off in an affray, (not cropped off for larceny), and obtained a Court certificate to that effect.

In those days, inn-keepers were not allowed to charge at their own discretion, for the drinks and other entertainments which they furnished to their patrons, but the court took the matter in hand and made a schedule of prices. In 1755, after fixing the prices for wine, whiskey, beer, etc., etc., they decided that the keepers of ordinaries, Inns or Taverns, should charge as follows,

For dinner of roast or boiled flesh 1 shilling.

For Supper and Breakfast each, 6 pence.

For Lodging overnight, good bed 2 pence

For Stablage (24 hours) with good hay or fodder 6 pence

For Pasturage, 1st 24 hours 4 pence every 24 hours after, 2 pence

For Indian corn or other grain, per quart 2 pence

This was to be paid in Proclamation money, which was about on par with Confederate the 2d or 3d year of the late war.

Salisbury was well supplied with licensed ordinaries, or inns, in those days. The licensed houses were as follows: In 1755 John Ryles's Ordinary was licensed. In 1756, John Lewis Beard, Peter Arrand, Jacob Franck, Archibald Craige, James Bower, and Thomas Bashford and Robert Gillespie received licenses. Jacob Franck occupied the lot where the late Dr. Alexander Long resided, and Bashford and Gillespie occupied the corner next to the present Court House, i.e. corner of Corbin and Council Streets, Robert Gillespie was the first husband of the celebrated Mrs. Elizabeth Steele, of Salisbury, and the father of the wife of the Rev. Samuel E. McCorkle, D.D. A few years after this, Paul Barringer Esq. of Mecklenburg (Cabarrus) bought the lot on the east corner of Corbin and Innes streets, 99 feet down Corbin and 198 ft. down Innes, from a man who is described as an "Ordinary keeper." From this it appears probable that the corner now occupied by Klutz's Drug Store was occupied as an Ordinary at an early day, as we knew that it was at a later day, when William Temple Coles kept an inn there, where John Dunn, Esq., died in the winter of 1782-3.

We may remark in passing that John Dunn and William Monat were appointed attorneys by Gov. Dobbs, and presented their Commissions to the Rowan Court in 1755. Of William Monat little or nothing appears in the Records of Rowan County; but for thirty years, John Dunn occupied a prominent place in the public affairs of Rowan County, both before and after the war of the Revolution. He deserved well of his country, and his name is embalmed in the hearts of a large circle of honored descendants, and is memory is perpetuated in the name of Dunn's Mountain, in sight of the Public Square of

Salisbury, at the foot of which his remains lie interred. This name will often recur in the course of these sketches.

At the June term of 1753, the Court proceeded to select a place for the erection of a court-house, pillory, stocks and goal. The action of the Court is substantially, as follows: "The Court House, goal and stocks shall be located where the "Irish settlement" forks, one fork leading to John Brandon's Esq., and the other fork along the old wagon road over Grant's Creek, called Sill's path, and near the most convenient spring." John Brandon, as stated before, lived six miles south of Salisbury, on the Concord Road, and "Sill's Path" was probably the Beattie's Ford road, crossing Sill's Creek, about seventeen miles west of Salisbury. The most "convenient spring" is thought to be a spring in the garden of the later Dr. Alexander Long, where Jacob Franck's Ordinary and still house were afterwards established, the lot afterwards owned by Matthew Troy, the father-inlaw, of the late Maxwell Chambers. The exact site of the Court house was the centre of our present public square, at the intersection of Corbin and Innes streets, where the great Town well now is. Tradition says that this spot -originally considerably higher than it now is – was a famous "deerstand," where the rifleman stood, and with unerring aim brought down the fleet-footed doe or antiered stag, as he fled before the music-making pack of hounds.

The Court directed that the Court House should be of frame-work, weather-boarded, thirty feet long and twenty feet wide, a story and a half high, with two floors, the lower one raised two feet above the ground. It was to be provided with an oval Bar, and a Bench raised three feet above the floor, with a table and seat for the Clerk, and "cases" for the attorneys. There was to be a good window behind the Bench, with glass in it, and a window near the middle of each side, and a door in the end opposite the Bench. This simple structure of wood, with one door and three windows, appears to us, after the lapse of a century and quarter, to have been an insignificant affair. But doubtless it compared favorably with the finest structures to be found the wilderness, only about ten years after the first settlers arrived, and it accorded well with the temper and the habits of those earnest and honest justices who sat upon the "Bench," and arraigned evil-doers at their bar. No complicated suits, involving nice points of law, often came before them for adjudication, but rather affrays, trespass and larcenies, with now and then a homicide, would make up the docket. Suits would not be apt to linger long. They did not erect a very large or very strong jail, for the culprit was apt to find himself speedily in the pillory, stocks or whipping post. I presume that few offences escaped upon legal technicalities, or on the plea of insanity, for the administrators of the law were more likely to consult the dictates of primitive justice, than the niceties of any written code or precedent.

STATE OF NORTH CAROLINA

Know all Men by these Presents, That We Hardy JONES and Jacob FISHER are held and firmly bound unto George H. BERGER, Montford STOKES and Mac CHAMBERS Esquires, and the rest of the Justices assigned to keep the peace for Rowan county, in the just and full sum of one thousand six hundred pounds, current money of the said state, to be paid to the said Justices heirs, executors, administrators, or assigns: To the "which payment well and truly to be made, we bind ourselves, and every of us, our and each of our heirs, executors, and administrators, jointly and feverally, firmly by these presents. Sealed with our seals, and dated this second day of August Anno Domini 1803

WHEREAS the above bounden Hardy JONES hath been this day, by the worshipful court of said county, appointed Guardian to Catharine BROOKS orphan of Humphay BROOKS deceased: Now the condition of the above obligation is such, that if the said Hardy Jones Guardian as aforesaid, shall well and truly discharge his said guardianship, by taking care of and improving all the estate belonging to the said orphan; and shall also settle his guardianship accounts with the court of said county, as is required by law; and that he will deliver up to the said Catharine BROOKS orphan as aforesaid, when he shall attain lawful age, all such estate as he ought of right to be possessed of, or sooner if required, agreeable to the true intent and meaning of the act of the General Assembly in such case made and provided; then this obligation to be void, otherwise to remain in full force and virtue.

Petition to Sell a Slave

It appearing to the satisfaction of the Court that the personal estate of Maria CHUNN, deceased (without the sale of a negro) is insufficient to pay her debts and the charges of the administration, and the cause coming on to be heard upon the petition of Thomas E. HYDE, Administrator of the said Maria CHUNN, deceased, and being heard accordingly, it is, therefore, ordered, adjudged ad decreed by the Court that Thomas E. HYDE, Administrator of the said Maria Chunn, deceased, sell a slave named Stephen, belonging to said estate in order to pay so much of the said debts and charges of the administration as are remaining unpaid. It is further ordered, adjudged and decreed that the said Thomas E. HYDE, Administrator, after Twenty days advertisement at the Court House door in Salisbury, and at three or more public places in the County of Rowan, proceed to sell said slave at the Court House in Salisbury, to the highest bidder at public auction, on a credit of six months, the purchaser giving bond with approved security. It is further ordered, adjudged and decreed that Thomas E. HYCE, Administrator, shall, out of the proceeds of the sale, pay off the liabilities remaining against the estate after all the prior assets have been exhausted, and the remaining funds, (if any), arising from the sale, he shall pay over to the next of kin and heirs-at-law of the said Maria CHUNN. deceased, and that said Administrator make his return to the next term of this Court.

THE PETITION of J.W. KESLER Administrator of Nicholas BRINGLE deceased, respectfully showeth, that he was appointed Administrator of said intestate by the Judge of Probate of said County, on the 24th day of May, 1873, and at once entered upon the administration of said estate:

Your Petitioner further showeth:

- I. That, from the best information and knowledge which he has been able to obtain, the outstanding debts of the said estate, amount to about Three Hundred Dollars.

Said lands subject however to the dower of Dorothy J. BRINGLE the widow of said intestate, which has not been heretofore allotted to her.

YOUR PETITIONER FURTHER SHOWETH, That a sale of said lands (subject to the widows Dower) is necessary for him to Enable him to pay the debts of his intestate, and the charges of administration. TO THE END THEREFORE, that said land may be sold by your Petitioner under a decree of this Court, on such terms as the court may direct and that the proceeds of the sale may constitute assets in his hands for the payment of said debts and charges, your petitioner prays, that a summons, with a copy of this petition, be issued to the said G.W. BRINGLE, Gen Jackson BRINGLE, Mary J. BRINGLE, Linda S.R. BRINGLE, John L.A. BRINGLE and Catherine BRINGLE.

That on July 9, 1926 Wachovia Bank and Trust Company qualified as Administrator of the estate of C.M. BROWN, who died intestate on Wednesday, July 7, 1926, and that the said Wachovia Bank and Trust Company did enter upon its duties as Administrator of this estate, which is valued a approximately \$20,000.00.

That the wife of C.M. BROWN died about eleven years prior to his death and the said C.M. BROWN did erect at her grave a monument or tombstone of modest cost and proportions and that Carl B. BROWN, son of C.M. BROWN, Mr Henry BROWN, the brother of C.M. BROWN, and Mrs F.V. BERRIER, all of Salisbury, request that there be erected at the grave of C.M.BROWN a monument or tombstone which shall be as nearly as possible a duplicate of that which was erected at the grave of Mrs C.M. BROWN.

III

That your Petitioner, the Wachovia Bank and Trust Company, Administrator of the estate of C.M. BROWN, after investigation and competitive bids, finds that the cost of the said duplicate monument or tombstone, including the small foot stone and including also cleaning and repair of the stone at the grave of Mrs C.M. BROWN, will amount to \$165.00, which sum is slightly in excess of that authorized by the law of North Carolina.

Wherefore, your Petitioner, considering that the request of the relatives of C.M. BROWN is reasonable and that the cost of the said stone is in keeping with the size and value of the estate of C.M. BROWN, prays that an order be granted authorizing the disbursement of \$165.00 for the coast of said stone and marker and for the cleaning of the stone at the grave of Mrs BROWN.
