#### **MEMBERSHIP RECRUITMENT**

Many clubs are proactive in membership recruitment. They have a Membership Chairman or a Membership Officer. But, MEMBERSHIP is the job of every member!

Here are **Membership Truths** that we should all live by!

- 1. Everyone is on the Membership Team; there are no exceptions!
- 2. Keep a list of Prospective members & regularly invite them to meetings & events; it often takes more than one communication or interaction for people to join.
- 3. Prospective members often need to read newspaper articles in your paper for a year or two before acting on what they read.
- 4. Retention begins the day a member joins your club.
- 5. Make sure a member feels that there is a place for her, her ideas, her input and participation in your club. Get members involved right away. Make them feel important.
- 6. Ask all members for their input. This shows members that their opinions count. Act on the opinions & suggestions you get from new & old/valued members. If you do not act on the input, you are saying that their opinions do not count. The action must follow the suggestions.
- 7. Pay the members for their efforts by rewarding them. Recognition is key. You must say "Thank You" often either in front of the group, in your minutes, in your newsletter, by small token gifts and any other way you can think of. You must say THANK YOU often; it's worth repeating.
- 8. Membership is about serving your member's needs. Think about why you belong to your club; **you do** get something out of it as well as all the other good reasons. It does something for you personally.
- 9. A successful club or organization gives something to its members as well as to the community it serves. We do good things for our communities. We also do good things for our members. Friendship is a huge part of our success. Keep things friendly.
- 10. The way to keep members is to create a true membership experience for them. Do they feel special because of the friendships? That they are

helping babies, high school students, elderly people, vets, or homeless pets are all good, but friends may be better. All these things work together.

- 11. Strive to make each member feel she is special, needed and that there is a unique value received from membership in this club that cannot be found anywhere else. "Only our Women's club helps babies each year with the Baby Car Seat Safety Check in our community, and you ladies help the club to make this event a success each year. Without you it could not be done!"
- 12. Communicate with your members. Members want to know what is going on even if they can't make it to any or all the meetings. It is okay if members can't attend all the meetings. It is our job to let them know what is happening by email blasts, Facebook, newsletters, US Mail, and telephone trees -whatever it takes.
- 13. Some members help by paying their dues and writing checks. That is okay too. We are not all doers. Some may not be healthy enough to be doers. We need some people who are willing to pay the bills.
- 14. Have a Membership Plan. A simple plan is okay. For example--We will go to the Community Summer Yard Sale and Holiday Gift Wrapping day events and invite people to join our club. Having no plan is a plan to fail.

#### **GFWC-NC BYLAW - ARTICLE XI**

**Section 11.3.** A Club having between 5 and 9 members shall be entitled to be represented by its President or her representative as its delegate. A Club having between 10 and 25 members shall be entitled to be represented by its President or her representative as its delegate and one additional delegate. A Club having more than 25 members shall be entitled to one additional delegate for each additional 25 members or majority thereof after the first 25.

Section 11.4. Members of the GFWC-NC entitled to vote shall be the Executive Committee, Junior Officers, Board of Trustees, Chaplain, Parliamentarian, Historian, Protocol Chairman, Community Service Program Chairmen, Arts Festival Contest Chairmen, Chairmen and members of Standing and Special Committees, Chairmen of Special Projects; District Presidents, Vice Presidents, Junior Directors, and Junior Membership Chairmen; GFWC-NC Past Presidents and Directors of Junior Clubs who are members of federated NC clubs; members serving GFWC in an official capacity; and club delegates. No proxies shall be permitted.

She is a board member of Girls' Leadership Academy of Wilmington (GLOW), the first all-girls' NC charter school and

an affiliate of the Young Women's Leadership Network. She is a tireless advocate for youth with special needs and learning differences. She was named a 2001-2003 William C. Friday Human Relations Fellow.

Her diverse accomplishments include making an impact in the arts, supporting young people's education, actively working toward positive environmental goals, and encouraging responsible public decisions, all while raising her son.

Bylaws, Article XXVI, Section 26.2 These bylaws may be amended at the annual convention of the GFWC-NC by a two-thirds vote of the registered delegates present and voting, notice of the amendments having been appended to the Call of Convention.

Proviso: Amendments affecting the changes in the position of Corresponding Secretary will become effective with the 2020-2022 Administration. (Marked with \* in Bylaws)

**Current Article V - Officers and their Election, Section 5.1.** The officers shall be: President, President-elect, First Vice President, Second Vice President, Third Vice President, Recording Secretary, Corresponding Secretary, and Treasurer.

**Proposed Amendment:** Strike Corresponding Secretary. **If amended, will read: Article V - Officers and their Election, Section 5.1.** The officers shall be: President, President-elect, First Vice President, Second Vice President, Third Vice President, Recording Secretary, and Treasurer. \* **Rationale:** To align position with GFWC-NC Junior Section

**Current Article V - Officers and their Election, Section 5.2.** No two officers shall be from the same club with the exception of the Corresponding Secretary.

**Proposed Amendment:** Strike with the exception of the Corresponding Secretary and insert of record.

If amended, will read: Article V - Officers and their Election, Section 5.2. No two officers shall be from the same club of record. \*

**Rationale:** To reflect change in Corresponding Secretary position.

**Current Article VI - Executive Committee, Section 6.4(G).** Fill all vacancies that occur between annual conventions, except Board of Trustees, President, President-elect and Third Vice President.

**Proposed Amendment:** Following "conventions" strike except, and insert with the exception of. Following "Board of Trustees" strike President, President-elect and Third Vice President, and insert and Executive Committee. Add new sentence, In the event vacancies of the Board of Trustees and Executive Committee occur, the Nominating Committee for Officers shall present nominees to be approved by the Executive Committee.

If amended, will read: Article VI - Executive Committee, Section 6.4(G). Fill all vacancies that occur between annual conventions, with the exception of Board of Trustees and Executive Committee. In the event vacancies of the Board of Trustees and Executive Committee occur, the Nominating Committee for Officers shall present nominees to be approved by the Executive Committee.

Rationale: Correct inconsistencies.

**Current Article VII –Board of Trustees, Section 7.6** The Board of Trustees shall have charge of all investments of all endowed funds and/or real estate made in the name of and belonging to the GFWC-NC.

**Proposed Amendment:** Strike investments of all endowed funds and replace with invested funds

**If amended, will read: Article VII – Board of Trustees, Section 7.6.** The Board of Trustees shall have charge of all invested funds and/or real estate made in the name of and belonging to the GFWC-NC.

**Rationale:** To reflect current practice

**Current Article VII - Board of Trustees, Section 7.10.** The Board of Trustees shall act as a financial advisory board for the Sallie Southall Cotten Scholarship Committee.

Proposed Amendment: Strike Sallie Southall Cotten.
If amended, will read: Article VII - Board of Trustees, Section 7.10. The Board of Trustees shall act as a financial advisory board for the Scholarship Committee.

**Rationale:** To update and reflect committee changes. (For reference, please see proposed new section for Article XX – Standing Committees.)

**Current Article XIII - Nominations and Elections, Section 13.1.** Nominees for the offices of President-elect, First Vice President, Second Vice President, Third Vice President, Recording Secretary, Corresponding Secretary, and Treasurer shall be presented by the Nominating Committee for Officers at the first business session of the convention in even years, to serve a term of two years.

Proposed Amendment: Strike Corresponding Secretary. If amended, will read: Article XIII - Nominations and Elections, Section 13.1. Nominees for the offices of President-elect, First Vice President, Second Vice President, Third Vice President, Recording Secretary, and Treasurer shall be presented by the Nominating Committee for Officers at the first business session of the convention in even years, to serve a term of two years. \*

**Rationale:** To update and reflect changes to Executive Committee.

**Current Article XIII - Nominations and Elections, Section 13.2.** If a vacancy occurs in the office of President, the President-elect shall become President and serve the remainder of the term. If a vacancy occurs in the office of President-elect or any other office of the Executive Committee, the Nominating Committee for Officers shall present a nominee for that office to be approved by the Executive Committee and confirmed by the Board of Directors at their next meeting.

**Proposed Amendment:** In the 2nd sentence, following "If a vacancy occurs," insert *on the Board of Trustees or* and following "any other office of the Executive Committee," insert *except Third Vice President*. Strike and confirmed by the Board of Directors at their next meeting.

If amended, will read: Current Article XIII - Nominations and Elections, Section 13.2. If a vacancy occurs in the office of President, the President-elect shall be-

come President and serve the remainder of the term. If a vacancy occurs on the Board of Trustees or in the office of President-elect or any other office of the Executive Committee, except Third Vice President, the Nominating Committee for Officers shall present a nominee for that office to be approved by the Executive Committee.

Rationale: To correct inconsistencies.

**Current Article XIII - Nominations and Elections, Section 13.4.** The nominee for President-elect shall have served as a club president. She shall have served as either a GFWC-NC Community Service Program Chairman or a District President and shall have served on the GFWC-NC Executive Committee.

**Proposed Amendment:** Following "Chairman," insert an Advancement Area Chairman.

If amended, will read: Article XIII - Nominations and Elections, Section 13.4. The nominee for President-elect shall have served as a club president. She shall have served as either a GFWC-NC Community Service Program Chairman, an Advancement Area Chairman, or a District President and shall have served on the GFWC-NC Executive Committee.

Rationale: To broaden leadership opportunities

**Current Article XIII - Nominations and Elections, Section 13.5.** The Nominating Committee shall nominate only clubwomen who have held office in their clubs and are active in district and GFWC-NC work. The nominee for First Vice President shall have served as a Community Service Program Chairman in the GFWC-NC. The nominee for Second Vice President shall have served as a District President of the GFWC-NC.

**Proposed Amendment:** In the 2nd sentence, following "Chairman," insert *or an Advancement Area Chairman*.

If amended, will read: Current Article XIII - Nominations and Elections, Section 13.5. The Nominating Committee shall nominate only clubwomen who have held office in their clubs and are active in district and GFWC-NC work. The nominee for First Vice President shall have served as a Community Service Program Chairman or an Advancement Area Chairman in the GFWC-NC. The nominee for Second Vice President shall have served as a District President of the GFWC-NC.

Rationale: To broaden leadership opportunities

**Current Article XIV - Duties of Officers, Section 14.2**. The President-elect shall assist the President as requested and shall perform the duties of the President in her absence. She shall serve as Chairman of the GFWC-NC Membership Committee. She shall work in conjunction with the Director-elect of Junior Clubs, the District Vice Presidents and the District Junior Membership Chairmen. She shall promote and encourage membership through the support, training and recruitment of members, and the development and federating of new clubs. In the second year of the administration, she shall become an ex-officio member of the Board of Trustees, Finance, Resolutions, and

Bylaws Committees and shall plan for the next administration, involving the nominees for state officers. She shall also involve the Community Service Program Chairmen and District Presidents who will be confirmed at convention. She shall appoint a Chaplain, Historian, Parliamentarian, Protocol Chairman, Standing Committees, except the Nominating Committees, and such Special and Project Committees as may be necessary for the next administration. If a vacancy occurs in the office of President, the President-elect shall become President and serve the remainder of the term. She shall serve on the GFWC-NC Long-Range Planning and Personnel Committees.

**Proposed Amendment**: In the 7th sentence, following "She shall appoint a," insert *Corresponding Secretary*.

If amended, will read: Article XIV - Duties of Officers, Section 14.2. The President-elect shall assist the President as requested and shall perform the duties of the President in her absence. She shall serve as Chairman of the GFWC-NC Membership Committee. She shall work in conjunction with the Director-elect of Junior Clubs, the District Vice Presidents and the District Junior Membership Chairmen. She shall promote and encourage membership through the support, training and recruitment of members, and the development and federating of new clubs. In the second year of the administration, she shall become an exofficio member of the Board of Trustees, Finance, Resolutions, and Bylaws Committees and shall plan for the next administration, involving the nominees for state officers. She shall also involve the Community Service Program Chairmen and District Presidents who will be confirmed at convention. She shall appoint a Corresponding Secretary, Chaplain, Historian, Parliamentarian, Protocol Chairman, Standing Committees, except the Nominating Committees, and such Special and Project Committees as may be necessary for the next administration. If a vacancy occurs in the office of President, the President-elect shall become President and serve the remainder of the term. She shall serve on the GFWC-NC Long-Range Planning and Personnel Committees. \*

**Rationale:** To update and reflect changes to Executive Committee.

**Current Article XIV - Duties of Officers, Section 14.8.** The Corresponding Secretary shall assist the President with the general correspondence of the GFWC-NC. She shall direct public relations activities and serve as an ex-officio member of the Public Relations Committee. With approval of the President, she shall provide press releases and oversee the website. She shall perform other duties assigned her by the President or Executive Committee.

**Proposed Amendment:** Strike Section 14.8 in its entirety. Renumber following section accordingly.

**If amended, will read:** Section 14.8 is deleted and the remaining section is renumbered accordingly. \*

**Rationale:** To update and reflect changes to Executive Committee.

**Current Article XVIII - District Officers, Section 18.1**. It shall be the duty of the District President to preside at all District meetings, to appoint all District Chairmen other than Community Service Program Chairmen, to cooperate with the GFWC-NC Second Vice President, and to promote club work in general throughout the District. Each District President shall cooperate with the GFWC-NC President-elect and District Vice President in organizing and federating clubs, and shall serve in her District in an advisory capacity to the Sallie Southall Cotten Scholarship Committee. She shall keep a record of work, finished and unfinished, and pass it on to her successor.

**Proposed Amendment:** Strike 2nd and 3rd sentences: Each District President shall cooperate with the GFWC-NC President-elect and District Vice President in organizing and federating clubs, and shall serve in her District in an advisory capacity to the Sallie Southall Cotten Scholarship Committee. She shall keep a record of work, finished and unfinished, and pass it on to her successor.

**If amended, will read:** Article XVIII - District Officers, Section 18.1. It shall be the duty of the District President to preside at all District meetings, to appoint all District Chairmen other than Community Service Program Chairmen, to cooperate with the GFWC-NC Second Vice President, and to promote club work in general throughout the District.

**Rationale:** To broaden the scope.

**Current Article XX - Standing Committees, Section 20.1.** The Arts Festival Committee shall consist of a chairman and contest chairmen appointed by the President for implementation of the contests in the Arts, Crafts, Literature, Performing Arts, and Artfest Programs.

**Proposed Amendment:** Following "Literature," strike Performing Arts.

If amended, will read: Article XX - Standing Committees, Section 20.1. The Arts Festival Committee shall consist of a chairman and contest chairmen appointed by the President for implementation of the contests in the Arts, Crafts, Literature, and Artfest Programs.

Rationale: Due to lack of participation.

**Current Article XX - Standing Committees, Section 20.4.** The Communications and Public Relations Committee shall consist of a chairman, the Junior Editor, and an unlimited number of members appointed by the President. It shall be the duty of the committee to promote and ensure the implementation of the tools necessary for proper communication, public awareness and public relations, including but not limited to the promotion of media relations, social media and website. Interested clubwomen may be appointed by the President at any time. The GFWC-NC Corresponding Secretary shall serve as an ex-officio member of this committee.

**Proposed Amendment**: After "including but not limited to" insert *The GFWC Clubwoman/GFWC-NC Clubwoman magazines and* and strike last sentence, The GFWC-NC Corresponding Secretary shall serve as an ex-officio member of this committee.

If amended, will read: Article XX - Standing Committees, Section 20.4. The Communications and Public Relations Committee shall consist of a chairman, the Junior Editor, and an unlimited number of members appointed by the President. It shall be the duty of the committee to promote and ensure the implementation of the tools necessary for proper communication, public awareness and public relations, including but not limited to The GFWC Clubwoman/GFWC-NC Clubwoman magazines and the promotion of media relations, social media and website. Interested clubwomen may be appointed by the President at any time. \*

**Rationale:** To update and reflect changes to Executive Committee.

**Current Article XX - Standing Committees, Section 20.5.** The Convention Committee shall consist of at least two members, one of who shall be the Junior Editor. This committee shall assist the President in planning for convention and in cooperation with the GFWC-NC Executive Administrative Assistant shall coordinate all activities of the convention.

**Proposed Amendment:** Strike Section 20.5 in its entirety.

**If amended, will read:** Section 20.5 is deleted and the remaining sections will be renumbered accordingly.

**Rationale:** In line with current practice.

**Current Article XX - Standing Committees, Section 20.8**. The *GFWC Clubwoman/North Carolina Clubwoman Committee* shall consist of a Chairman, appointed by the President. It shall be the duty of the chairman to promote these publications and assist the GFWC-NC Editor as the need arises.

**Proposed Amendment:** Strike Section 20.8 in its entirety

**If amended, will read:** Section 20.8 is deleted and the remaining sections will be renumbered accordingly.

**Rationale:** Responsibilities of this committee to be included in the responsibilities of the Communications and Public Relations Committee.

**Current Article XX - Standing Committees, Section 20.10.** The GFWC-NC Long-Range Planning Committee shall consist of a chairman appointed by the President, the President-elect, the Second Vice President, the Director-elect of Junior Clubs, the Treasurer, the Junior Secretary, and at least one other clubwoman appointed by the President. Amendments shall be submitted to this committee by the annual convention. This committee shall meet over the summer to develop a Strategic Plan, regularly review the adopted plan, consider proposed amendments, and submit the updated plan to the Executive Committee for review by August 1 of the uneven year. The plan will then be appended to the Call of the Fall Conference for adoption by the Board of Directors.

Proposed Amendment: In the 2nd sentence, insert *in the uneven year* following "convention." In the 3rd sentence, strike <del>over the summer.</del>

- 2. Encourage bicycle riders to be aware of the risk and dangers of riding on public roads where there is no bike lane.

- 4.Support legislation requiring safety helmet use by all persons regardless of age who are using transportation alternatives including but not limited to bicycles, golf carts, motorcycles, mopeds, scooters, all-terrain vehicles (ATVs), skates, skateboards, scooters, Segways, and hover boards, and;

5. Oppose the repeal of state law which requires use of safety helmets by motorcyclists, and further

**RESOLVED**, That GFWC of North Carolina, Inc. urges support for the construction of bike lanes and facilities to promote safety on public streets and roads.

**NC Broadband Authority & Utilization** (Convention 2014; formerly E-NC Authority, Convention 2007)

WHEREAS, Broadband is a high-capacity transmission technique using a wide range of frequencies, which enables a large number of many messages to be communicated simultaneously; another term for bandwidth-or the amount of data that can be sent through a connection-to access high-speed Internet, and the more bandwidth, the more information a user can send or receive at any given time; and

WHEREAS, Broadband technology for businesses and citizens is a key component to economic development, education and government efficiency for our state; and

WHEREAS, North Carolina's broadband deployment rate ranks roughly equal to the U.S. average, but the availability of broadband decreases considerably at higher speeds, and data trends suggest that the need and demand for faster broadband speeds is growing and will continue to grow rapidly; and

WHEREAS, Broadband access at home is critical for North Carolina school children as the state moves to online textbooks in 2017, for online learning overall, for teleworking, and for home-based businesses; and

WHEREAS, The remaining areas in North Carolina unserved by broadband are likely to remain unserved without concerted efforts to develop last-mile solutions for these areas; and

WHEREAS, Broadband adoption is the demand side of the economic equation that allows companies to invest in building out broadband infrastructure based on consumers subscribing to these services, and North Carolina has average adoption rates for the lowest broadband speeds, but as speeds increase, adoption rates decrease dramatically; and

WHEREAS, Broadband adoption is a complex challenge with many factors impacting uptake of broadband such as cost and income levels, literacy, and digital literacy, access to devices, availability of other public Internet access such as libraries, and relevancy; and

WHEREAS, Solving the adoption challenge directly impacts the rate of future deployment and growth in the state, and having a digitally literate and active population directly impacts educational and workforce preparedness for the state, and digital exclusion by sectors of population will become more and more expensive for governments and other groups of fering services online; and

WHEREAS, Local engagement and focus on broadband planning from county leadership, economic developers, businesses, schools, communities, and citizens is necessary to try to move the needle forward for increases broadband availability, adoption and use; and

WHEREAS, The GFWC of North Carolina, Inc., believes that all citizens, schools, and businesses in North Carolina benefit from the availability and utilization of affordable broadband Internet access; therefore

**RESOLVED**, That the GFWC of North Carolina, Inc., urges its member clubs to support local broadband planning and engagement efforts in partnership with regional and state efforts, to continue the growth of broadband infrastructure and utilization for the increased competiveness of North Carolina, and to benefit its communities and citizens.

# **HOBY Program in Warrenton**

Two local students have been chosen to participate in a leadership program this summer, marking the second consecutive year that Warren County teens have participated.

Founded in 1958, the Hugh O'Brian Youth leadership program, commonly known as HOBY, provides programs for rising juniors selected by their schools to participate in leadership training, service-learning projects and experiences that build motivation. HOBY's mission is to "inspire and develop our global community of youth and volunteers to a life dedicated to leadership, service and innovation." Core values of the program are volunteerism, integrity, excellence, diversity and community partnership.

Local students participating this summer at the East Region leadership seminar at N.C. State University in Raleigh are Alaina Pulley and Ryan Baskerville, who attend Warren New Tech High School. They both said they are "really excited" about being a part of the HOBY experience.

Pulley said she looked forward to meeting new people and giving back to the community when she returns. She currently performs community service work through her dance studio.

Baskerville has been involved in community service work locally as a mentor for the robotics team and the STEM Club at Warren County Middle School and as a mentor for the NASA Science, Engineering, Mathematics and Aerospace Academy based at Warren County High School. Also, he helps keep local roadways clean since his mother adopted a highway here.

He said he also looked forward to meeting new people and sharing experiences with peers who have similar character traits.

Characteristics sought after for HOBY candidates include critical thinking, written and oral communication skills; being sensitive to others; and an interest in community service.

Last summer, the GFWC-Warrenton Woman's Club sponsored for the first time local students who attended HOBY in June. They were Juan Luna from WNTHS, Danaja Lee from Warren Early College High School and K.W. Reid, a student at Warren County High School.

"I'm a true believer that you should teach young people to be true leaders, and give them the confidence and the background to do that," said Jana Miller, president of the Warrenton Woman's Club.

Luna said through attending HOBY, he gained leadership skills and enjoyed the community service projects of making blankets for dogs and planting trees.

Locally, he has helped edit videos for students

to learn mathematics when they didn't have a class-room teacher.

Lee said her favorite part of HOBY was getting to know other people, and through social media she still keeps in touch with people that she met. She also enjoyed the community service aspect.

She recently helped her school with its Christmas parade float, and she has been a volunteer at the Animal Ark shelter.

"(HOBY) was an open-minded place where they asked us questions about ourselves and you're around people like you," Lee said. "You learn different leadership skills, and the activities were really fun. I learned a lot."

Miller, who said she hopes her club can sponsor other students in the future, stressed the importance of networking.

"They (the students) can make lifelong contacts, connections that are critical for so many of these students going out of their box," she said. "It's a lifetime experience that will be there forever and gives them educational opportunities they otherwise wouldn't have. Maybe they will come back to the community and bring new things to the county and their own ideas.

**WHEREAS**, Broadband is a high-capacity transmission technique using a wide range of frequencies, which enables many messages to be communicated simultaneously; and

If amended, will read: Article XX - Standing Committees, Section 20.10. The GFWC-NC Long-Range Planning Committee shall consist of a chairman appointed by the President, the President-elect, the Second Vice President, the Director-elect of Junior Clubs, the Treasurer, the Junior Secretary, and at least one other clubwoman appointed by the President. Amendments shall be submitted to this committee by the annual convention in the uneven year. This committee shall meet to develop a Strategic Plan, regularly review the adopted plan, consider proposed amendments, and submit the updated plan to the Executive Committee for review by August 1 of the uneven year. The plan will then be appended to the Call of the Fall Conference for adoption by the Board of Directors.

Rationale: To update

**Current Article XX - Standing Committees, Section 20.11**. The Headquarters Committee shall consist of a chairman and two members appointed by the president to assist the staff as needed.

**Proposed Amendment:** Strike Section 20.11 in its entirety.

**If amended, will read:** Section 20.11 is deleted and the remaining sections will be renumbered accordingly.

**Rationale:** To conform to current practice.

**Current Article XX - Standing Committees, Section 20.19**. The Public Policy/Legislative Committee shall consist of a Chairman, appointed by the President, and one member from each district, appointed by each District President. This committee shall be responsible for keeping clubs informed on such legislative/public policy matters as have been approved by the GFWC-NC Conventions. The President and the chairman shall represent the GFWC-NC to the appropriate organizations. All expenses of this committee will be recorded in a separate account and kept within the nontaxable limit provided in the Internal Revenue Code.

Proposed Amendment: In the first sentence, insert and two members following "Chairman." Strike and one member from each district, appointed by each District President. If amended, will read: Article XX - Standing Committees, Section 20.19. The Public Policy/Legislative Committee shall consist of a Chairman and two members, appointed by the President. This committee shall be responsible for keeping clubs informed on such legislative/public policy matters as have been approved by the GFWC-NC Conventions. The President and the chairman shall represent the GFWC-NC to the appropriate organizations. All expenses of this committee will be recorded in a separate account and kept within the nontaxable limit provided in the Internal Revenue Code.

Rationale: To redefine committee membership.

#### JUNIOR SECTION

Current Article IV - Duties of Officers, Section 4.2. The Director-elect of Junior Clubs shall promote and assist existing Junior clubs in their efforts to establish new Junior clubs and increase the size and effectiveness of present membership. She shall work on the Membership Commit-Page 26-Spring 2018

tee with the GFWC-NC President-elect and the District Junior Membership Chairmen. In the absence of the Director of Junior Clubs, she shall serve as Chairman of meetings of the Junior Board and at annual meetings of the Junior Section. If a vacancy occurs in the office of the Director of Junior Clubs in the first year of an administration, the Director-elect of Junior Clubs shall become Director of Junior Clubs and serve the remainder of the term.

The Director-elect of Junior Clubs shall serve on the Junior Board and assist the Director of Junior Clubs when requested. She shall attend any function pertaining to the position as Director-elect of Junior Clubs. In the second year of the Administration, she shall begin plans for her administration, involving Junior Program Chairmen, Project Chairmen, and District Junior Directors, District Junior Membership Chairs, and Junior appointments who shall take office at the next annual convention. Should a vacancy occur in the second year of an administration, she shall assume the office of Director of Junior Clubs.

**Proposed Amendment:** In last sentence of the first paragraph strike the first year of and in the last sentence of the section, strike Should a vacancy occur in the second year of an administration, she shall assume the office of Director of Junior Clubs.

If amended, will read: Article IV - Duties of Officers, Section 4.2. The Director-elect of Junior Clubs shall promote and assist existing Junior clubs in their efforts to establish new Junior clubs and increase the size and effectiveness of present membership. She shall work on the Membership Committee with the GFWC-NC President-elect and the District Junior Membership Chairmen. In the absence of the Director of Junior Clubs, she shall serve as Chairman of meetings of the Junior Board and at annual meetings of the Junior Section. If a vacancy occurs in the office of the Director of Junior Clubs in an administration, the Director-elect of Junior Clubs shall become Director of Junior Clubs and serve the remainder of the term.

**Current Article IV - Duties of Officers, Section 4.6.** The Junior officers, together with the President of the GFWC-NC as an ex-officio member, shall constitute a Junior Extension Committee, which shall transact the business of the Junior Section between conventions. All vacancies in offices of the Junior Section with the exception of the Third Vice President (Director of Junior Clubs) which occur between conventions shall be filled by the Junior Extension Committee.

**Proposed Amendment:** Strike 2nd sentence, All vacancies in offices of the Junior Section with the exception of the Third Vice President (Director of Junior Clubs) which occur between conventions shall be filled by the Junior Extension Committee.

If amended, will read: Article IV - Duties of Officers, Section 4.6. The Junior officers, together with the President of the GFWC-NC as an ex-officio member, shall constitute a Junior Extension Committee, which shall transact the business of the Junior Section between conventions.

**Rationale:** For consistency.

**Current Article V – Nominations and Elections, Section 5.3** The Junior Nominating Committee shall present the names of nominees for the offices of Directorelect of Junior Clubs, Dean of Junior Community Service Programs, Junior Secretary, and Junior Editor at the annual Fall Conference Meeting of the Junior Board, the slate having been completed by August 1 of the uneven vear. The names, pictures, and biographical sketches of the nominees for Junior Officers are to be included in the following winter issue of the North Carolina Clubwoman. The slate shall be presented by the Junior Nominating Committee at the convention in even years. Further nominations may be made from the floor with the prior consent of the nominee. Voting shall be by written ballot unless there is only one nominee for each office. The vote may then be taken by viva-voce or by acclamation. No Junior Officer may serve more than one full term in the same office. A Junior Officer serving less than one year of a term may be eligible for reelection.

**Proposed Amendment:** First sentence strike annual and in the third sentence insert *Junior Business Session* at after "Junior Nominating Committee at the."

If amended will read: Article V – Nominations and Elections, Section 5.3 The Junior Nominating Committee shall present the names of nominees for the Offices of Director-elect of Junior Clubs, Dean of Junior Community Service Programs, Junior Secretary, and Junior Editor at the Fall Conference Meeting of the Junior Board, the slate having been completed by August 1 of the uneven year. The names, pictures, and biographical sketches of the nominees for Junior Officers are to

be included in the following winter issue of the *North Carolina Clubwoman*. The slate shall be presented by the Junior Nominating Committee at the Junior Business Session at convention in even years. Further nominations may be made from the floor with prior consent of the nominee. Voting shall be by written ballot unless there is only one nominee for each officer. The vote may be taken by viva-voce or by acclamation. No Junior Officer may serve more than one full term in the same office. ## **Proposed New Section: Current Article XX - Standing Committees**

Section 20.17. The Lucy Bramlette Patterson Award Committee shall consist of a chairperson and two members appointed by the President. The award will be given in honor of a female writer who is either a native of North Carolina or currently resides in the state. The honoree shall attend and be presented at the annual convention of GFWC-NC. Clubs may submit nominations for this award.

Section 20.21. The Sallie Southall Cotten Scholarship (SSCS) Committee of the GFWC-NC shall consist of a chairman appointed by the President for a two-year term, the Education Community Service Program Chairman and Junior Chairman. The Sallie Southall Cotten Scholarship Chairman shall receive applications of the District winners. Rules and regulations for this scholarship shall be approved by the Board of Trustees and the Executive Committee. Special meetings of the SSCS Committee may be called by the President or two members of the Board of Trustees.

**Section 20.22.** The Whitener Piano Scholarship Committee of the GFWC-NC shall consist of the Chairman and two members appointed by the President to serve for a two-year term. They shall receive the applications of the District winners and follow the rules and regulations for this scholarship which are approved by the Board of Trustees and the Executive Committee.

**Proposed Amendment:** Strike Sections 20.17, 20.21, and 20.22 in their entirety and insert new section in Article XX – Standing Committees.

New Section: The Scholarship Committee shall consist of a Scholarship Committee Chairman appointed by the President for a two-year term. Her committee shall consist of the Sallie Southall Cotten Chairman, Whitener Piano Chairman, Greeson-Johnson Teaching Scholarship Chairman, Lucy Bramlette Patterson Chairman and at least three additional members, all appointed by the President. Rules and regulations for these scholarships shall be approved by the Board of Trustees and the Executive Committee.

**Rationale:** To reorganize and streamline the Scholarship Committees.
