**\$15,000.** Nonprofit/arts internship stipends are designed to cover a variety of costs incurred by the student before and during the internship. These costs vary considerably based on the location and other factors specific to each intern's situation. These expenses may include transportation to/from the internship location, housing, meals, commuting to/from the workplace, and utilities. Because the funding from UCS only supports a portion of the experience, students generally combine multiple sources of funding to meet their needs. Given the unpaid nature of the internship and limited available funding, we are unable to fund all of the applicants. Each applicant must provide documentation of need, and UCS staff follows-up with stipend recipients to confirm they have fulfilled their internship obligations.

Our current nonprofit/arts internship stipend program is highly effective for the students we are able to fund. However, it could be twice as effective, if through receipt of the Parents Council Grant, we can double the number of students who receive stipends.



# Section D

Briefly explain why Parents Council funds are necessary for this program/event.

Last year, because we had to restrict our stipend program to only 30 current juniors (rising seniors during their internships), we excluded at least 30-40 non-juniors from being able to even apply for the program. This decision came about from previous years when we did allow non-juniors to apply but found we had to prioritize limited funds and, consequently, focused on only juniors who had one summer remaining before graduation to complete an internship. We would like to once again allow non-juniors to apply for this program, since so many of their nonprofits/arts internships are the kinds of experiences that will make them stronger candidates for future internships and, ultimately, for the job market or graduate/professional school.

Section E What other anticipated financial support, dollar amounts and resources is expected to be applied toward this grant proposal?

The current Dean and Wendy Painter Fund allows for 30 annual stipends to be given for nonprofit/arts unpaid interns at a cost of \$14,750 this past summer. This fund will continue to allow us to have a similar amount in future years.

The Parent's Council has made several generous donations to University Career Services these include a \$9,900 grant in 2009/10 to fund the UCS Non Profits and Arts Summer Internship Stipend program and \$44,716 between 1998 and 2000 for the renovation and furnishing of the UCS facility in Hanes Hall. UCS greatly appreciates the support and encouragement of the Parent's Council as we work to meet the career exploration and job search needs of all of our students.
