COVID 19 PANDEMIC

The coronavirus disease 19 (COVID-19) is a highly transmittable and pathogenic viral infection caused by severe acute respiratory syndrome coronavirus 2 (SARSCoV-2), which emerged in Wuhan, China and spread around the world..

On 30th January 2020, World Health Organization (WHO) officially declared the COVID19 epidemic as a public health emergency of international concern. In United States the first positive case was identified on January 19, 2020 in Washington state. The first positive case in North Carolina was reported on March 3rd, 2020.

COVID-19 is a new disease and there is limited information regarding risk factors for severe disease. Based on currently available information and clinical expertise, older adults and people of any age who have serious underlying medical conditions might be at higher risk for severe illness from COVID-19. The clinical symptoms of COVID-19 may appear 2-14 days after exposure to the virus. Clinical Symptoms: Fever, Cough, Shortness of breath or difficulty breathing, Chills, Muscle pain, are common ones.

How COVID19 Spreads:

- There is currently no vaccine to prevent coronavirus disease 2019 (COVID-19).
- The best way to prevent illness is to avoid being exposed to this virus.
- The virus is thought to spread mainly from person-to-person.
- Between people who are in close contact with one another (within about 6 feet).
- Through respiratory droplets produced when an infected person coughs, sneezes or talks.
- These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs.

How to Protect Yourself:

- Clean your hands often—Wash your hands with soap and water for at least 20 seconds especially after you have been in a public place or after blowing your nose, coughing or sneezing.
- If Soap and water not readily available, use a hand sanitizer that contains at least 60% alcohol. Cover all surfaces of your hands and rub them together until they feel dry.
- Avoid touching your eyes, nose and mouth with unwashed hands.
- Avoid close contact with people who are sick
- Cover your mouth and nose with a cloth face cover when around others
- Cover coughs and sneezes, remember to always cover your mouth and nose with a tissue when you cough or sneeze or close the inside of your elbow.
- Clean and disinfect frequently touched surfaces daily. This includes tables, doorknobs, light switches, countertops, handles, desks, phones, keyboards, toilets, faucets and sink.

What to expect in future:

Currently implemented interventions and the corresponding reductions in transmission will continue to be upheld in the future, resulting in an overall decrease in the growth rate of COVID-19. Over the course of the forecast, we shall assume that the growth will decrease over time.

Also, social distancing policies in place will be extended for the future weeks. Continue to practice – how to protect yourself from above. Please remember, even if NC opens after May 8th, we are still not "out of the woods", regardless reaching a stable number of new infections and hospitalizations
