Donors respond generously to fund-a-need appeal

MARC patrons attending the Summer Soirée fundraising gala responded to the organization's fund-a-need campaign with great enthusiasm and the utmost generosity. Thanks to the \$11,000 raised with this appeal, repairs and renovations have already begun at Wright Tavern. We are hopeful these funds will also make us eligible for additional grants to be awarded soon.

Built in 1816, the Rockingham County Historical Society excavated and restored Wright Tavern in the late 1960s and early 1970s. In 1971 the tavern was placed on the National Register of Historic Places, and it is noted as one of the finest examples of dog-run architecture in North Carolina.



The United States Postal Service leased the southeast wing of the tavern in 1981 and vacated the premises in 2015. Unfortunately, they left the building dirty and in need of repairs.

Since the Soirée, MARC has replaced two of the three 40-year old heating and air systems in the tavern, so the tavern will remain open throughout the winter. We have also completed extensive

cleaning in the Post Office area. The old rubber mat has been removed from the front porch to reveal the extent of damage caused by heavy mail carts, and we are researching the original materials and materials used during the first restoration process to determine the appropriate way to proceed with further repairs.

Wright Tavern is a significant location in Rockingham County, both for its architecture and for the role it has played as a home and social center in the heart of the county seat. We are most grateful for the stewardship of our members and friends, whose gifts make it possible for MARC to fulfill our obligation to preserve this historic landmark.

"The Vagabonds" visit Rockingham County

At the time of World War I, Henry Ford, Harvey Firestone, John Burroughs, and Thomas Edison began traveling the country on camping trips that captured the imagination of the nation. The men referred to themselves as *The Vagabonds*, which of course they were not. They made stops to sightsee, horseback ride, drink at recommended wells, and camp. Their trips began in 1914 and continued until


1924 when their great fame drew such large crowds that they could no longer travel freely.

The 1918 trip was booked as an outing through the Great Smokies. They moved along in six cars (two Packards for riding, two Model T's, and two Ford trucks) with seven drivers and helpers. Their route started in Pittsburgh, Pennsylvania, through the Allegheny Mountains to Tennessee, then crossing over through North Carolina, Virginia, and Maryland.



The abbreviated itinerary published by John Burroughs in his book, "Our Vacation Days of 1918," read: "Aug 28 – Arrived Knoxville at noon but passed on to Winston Salem where we had dinner at 3 P.M. guests of the Rotary Club, Forsythe Country Club.

Aug 29 – Passed through Martinsville, Roanoke and rested at Natural Bridge. Then to Lexington and Castle Inn."



Their map shows them traveling east from Winston Salem to Greensboro then due north to Martinsville and Roanoke. Local traditions, however, claim that *The Vagabonds* came along the Ellisboro Road in western Rockingham County and stopped to drink water from the well of Pleasant Benjamin "Ped" Neal. Also, a Mayodan resident, Harry Martin (now deceased), made mention of the entourage stopping in Mayodan in a conversation documented by Jeff Bullins in 1980. Mr. Martin remembered them asking for water and carbide during their very short stop in town.

The map route to Greensboro as it was published by Burroughs makes little sense. Greensboro would have been well off of a route from Winston Salem to Roanoke and they had to stay somewhere (Continued on page 5)

en route to get to Martinsville the next morning. A more logical route would have been using US Highway 158 out of Winston Salem, north along Ellisboro Road from Stokesdale (following the Atlantic and Yadkin railroad bed) to Madison and Mayodan picking up US Highway 220 (following the Norfolk and Western railroad bed) toward Martinsville and Roanoke. Did they camp somewhere north of Mayodan before they went into Virginia on the night of August 28, 1918?

This story needs research and confirmation of tradition. Can you help? Brenda Payne Roberts has provided the tradition that they did stop and have a drink at "Ped" Neal's well. A photograph of Burroughs, Thomas Edison, and Henry Ford surfaced in 1983 when we were publishing *The Heritage of Rockingham County History* with the note that they were said to have stopped on Ellisboro Road at the Payne Farm. Have you heard a tradition or, better still, do you have any additional documentation about *The Vagabonds* travel in Rockingham County?

Plaques to be placed on Wentworth homes

The Historic Preservation Committee of Wentworth is engaged in a project to place wooden plaques on the older homes in the historic village of Wentworth. The signs will designate the builders' names and the dates of construction. A special metal plaque will also be placed in front of the Irvin-Scales-Reid-Reynolds-Gunn house, the

residence associated with several families of prominence in North Carolina government.

The Irvin-Scales-Reid-Reynolds-Gunn house was erected in 1858 by Col. James Irvin (1819-1894). A merchant in Wentworth and Madison, he also served as Rockingham County's clerk of court during the early 1860s. His title, "Colonel," came from his appointment as Colonel of the 69th Regiment of the N.C. State Militia in May of 1863. Irvin sold his Wentworth home in 1866 and purchased a farm west of Reidsville.

Alfred M. Scales, an attorney and native of Rockingham County, began to purchase property in Wentworth in 1868. He purchased the former Irvin House in 1870. Over the years he served as a state legislator and U. S. congressman. During the Civil War he served as captain of Company H, 13th Regiment, North Carolina State Troops. In 1863 he was promoted to brigadier general in the Confederate Army. He was wounded twice in the service.

In 1873, Scales moved from Wentworth to Greensboro to practice law with his brother, J. I. Scales. Alfred Scales served as governor of North Carolina from 1884 until 1889. After

Governor Scales died in 1892, his widow, Kate, continued to own their home in Wentworth until she sold the property to Lucile Reid in 1899.

Lucile Reid was married to Reuben D. Reid on the 15th of May 1898. Although Lucile's maiden and married surnames were both Reid, she and Reuben were not related. Reuben was a son of former governor David Settle Reid and Henrietta Settle Reid. Lucile descended from the Wright family who owned Wright Tavern in Wentworth. In 1902, Reuben and Lucile had the home extensively remodeled by adding rooms and a hip roof to the structure.

Reuben Reid practiced law in Wentworth for twenty-five years and served as state senator for Rockingham County in 1907-1908. In June 1909 he suffered a stroke and died from its effects. Sometime later, Lucile moved the family from Wentworth to Spray (now part of Eden).

In 1924 Lucile sold her Wentworth home to John F. Reynolds, a retired Internal Revenue employee from Winston-Salem. Mr. Reynolds and his wife, the former Maude Wall of Missouri, had only one child, also named Maude Reynolds, who served as an art and music teacher at Wentworth High School. Mr. Reynolds served as Rockingham County state senator in 1929. He died in 1936 and his wife passed away in 1940. In 1944 their daughter sold the home to Bruce and Jo Gunn, reserving lifetime rights to reside there until her death in 1980. The Gunns continued to live in the house until their deaths in 2001 and 2002. The property was then sold at auction to the present owner, Lenny Welborn.

Wise choices in money management may benefit both you and MARC!

MARC recently learned about another way for your charitable donations be of great benefit to you as well as to MARC. If you are over age 70 1/2, you might be able to donate to MARC from your IRA required minimum distribution (RMD). By donating either all or a portion of your RMD, the distribution may not be taxable to you. And, you gain satisfaction knowing that you are preserving our county's history for generations to come.

Congress voted in 2015 to permanently exclude from income RMD distributions given directly to charities. Keeping some or all of your RMD out of your adjusted gross income could help you avoid the Medicare high-income surcharge or help to make a smaller portion of your Social Security benefits taxable. Please note that the gift must be written directly from the IRA manager to MARC in order to qualify for the RMD tax-free benefit.

Some limits apply, so **you should check with your tax professional about your particular circumstances** or refer to IRS Publication 590 for more information. We strongly encourage you to investigate this opportunity to invest your money wisely with MARC! We value the support of our friends in the community.

The Melungeons are a group of mixed ethnic people living throughout the Appalachians who are of interest to their neighbors, census takers historians and genealogists. Goinstown in the northwestern corner of Rockingham County was home to a similar community. Residents there were variously classified as black, white, and Indian over the course of a century. The Goins Indian School survived until all county schools were desegregated in the 1950s. In recent decades the community has dispersed, and descendants remaining in the area have assimilated into either white or black identity.

Julie is a filmmaker and photographer from Raleigh who has been documenting the Melungeons for almost two decades. Paul is the author of the book, *Pell Mellers: Race and Memory in a Carolina Pocosin*.


