RALEIGH–The 29th Annual Robert E. Lee Birthday Celebration attracted a standing-room only crowd of more than 300 at the NC State Capitol on January 20, 2018. Retired US Army Sgt. Major James Haymes of Richmond, Virginia, delivered the keynote address. All four North Carolina Confederate heritage organizations were represented and brought greetings. The event marked the first time in the history of the ceremony the Confederate First National Flag did not fly over the Capitol during the ceremony. Gov. 

Gentlemen of the Old North State,

We are quickly approaching Spring and our annual observances of Confederate Memorial Day across the state. As we ramp up for another season of honoring our ancestors, there are several things going on which demand your attention.

First, be on the lookout for mail from the Division. We are sending out a letter to every member explaining the situation involving the three Confederate monuments on the Capitol grounds in Raleigh and their potential removal at the hands of the NC Historical Commission. It is important you read this information and respond with your support to Heritage Defense Fund. The details of that letter will not appear in these pages as the information should be kept between members of the Division.

Further, the period for public comment on this controversy has now been opened and the NC Historical Commission has established a website where you may go and submit comments. Please visit www.ncdcr.gov/comment-relocation-monuments or mail your comments directly to:

NC Historical Commission Monuments Committee Attn: Dr. Kevin Cherry, Secretary 4610 Mail Service Center Raleigh, NC 27699 Here is a form response we suggest in case you do not have time to write your own words:

I believe the Governor's petition to remove the three Confederate monuments on the State Capitol grounds is in violation of the Monument Protection Act of 2015. I also believe for the Historical Commission to validate this petition is in violation of this law. The General Assembly and its leaders have repeatedly clarified the intent of the law, and it in no way gives the Governor or the Commission the authority to move these or any other monuments or memorials. Further, Confederate monuments and memorials are part of North Carolina's rich history, and the men and women they honor have countless descendants living in North Carolina today. The Commission should recognize the danger and folly involved in selective interpretation of North Carolina's history. The Commission should also recognize that poll after poll has shown that a majority of North Carolinians object to the removal of Confederate monuments. As stewards of the citizens of North Carolina, the Commission should remain true to the will of the people and favor truth over political expediency.

On March 3rd at 1:00 PM in the House Chamber of the State Capitol, we will be holding our annual Confederate Flag Day. Please make plans to attend. We had more than 300 participants for Lee Day and made a great impression on the public with that kind of turnout. Let's please do the same thing again for Flag Day.

Quickly, I will let you know that

our requests to fly the 1st National Flag over the State Capitol for Lee Day, Flag Day, and Confederate Memorial Day have been denied flatly for the time being. The Department of Administration, headed by Machelle Saunders, has indicated only the NC and U.S. flags will fly over the Capitol. While this is possibly subject to change through internal channels, and we are working on that, please note the flag will not fly for the foreseeable future. The only way to remedy this is to vote Governor Cooper out of office in the next gubernatorial election and hope that should a Republican win, he will reinstate the practice we have enjoyed for decades. I also remind you that although the General Assembly did call for the flying of the Confederate Flag over the Capitol on certain days of the year, in particular Confederate Memorial Day, it was only by resolution and as such, is not a binding statutory duty of the State.

Also, please mark your calendars for our 3rd annual Heritage Day at the General Assembly on May 8th. The event is all day so there is no particular time you must show up, however, the best times to be present are between 9:00 AM and 3:00 PM. There will be several additional events and features this year that I will announce as the date draws nearer. Please make plans to attend.

We are off to a great start for 2018. Our Winter DEC was a success and well organized by Brigade Commander Steve Hulen and the Mingo Camp. We have a new Division logo voted on by those in attendance. We are also poised to do our

duty in the fight for our monuments. I ask you rededicate yourself to the SCV's Charge and you show up whenever called upon for Division events. We will need every man on hand to hold off the enemy in 2018. Please step up and volunteer by contacting me at scvmechcav@hotmail.com if you have any talents or ideas you want to contribute to the Division's efforts.

It is especially important if any speakers need to be removed. Regretfully, as the speakers list was being updated after many years, we discovered a couple of speakers who had passed away. This reminds us every camp needs to make notification of a compatriot passing away a priority.

If one of our compatriots passes, please make sure your camp adjutant or commander completes the form for the "Last Roll" available at scv.secure-sites.biz/pdf/Last Roll fillable.pdf and sends the completed form to General Headquarters at membership@scv.org. Also e-mail a copy of the completed form to the Chaplain-in-Chief at drparker@ mdivs.edu; our Division Adjutant at ncdivisionadjutant@gmail.com and the Division Chaplain at rebelrev@hotmail.com. The chaplains will send condolences to the family. This is important because we do not want to unknowingly send correspondence to a passed compatriot for it to be received by a grieving family.

We encourage each of you to make sure your camp submits a Distinguished Camp Award form to Commander Andrew Johnson as a tool to review the activities of

your camp. These forms will be a resource in completing the national form which is recommended. As mentioned at the Summer DEC, camps not recognized with the General William D. McCain Distinguished Camp Award will be considered for other deserving recognition. There will be a camp recognized as the Superior Camp in the Army of Northern Virginia. Camps having at least 125 points will be recognized as an Outstanding Camp in the Army of Northern Virginia. Last year there were only two camps who submitted the forms in the entire Army of Northern Virginia. Those two camps were from our division and were recognized as the ANV Superior and Outstanding camps. I know many of your camps will be recognized with one of these awards witnessing your activities, but you will need to submit forms.

As many of us know there are compatriots who go beyond the call of duty for the Sons of Confederate Veterans. As Southern gentlemen, none of them do what they do as members for personal recognition. We all know it is never what any of us do, but it is what they did, our ancestors, that matters. Many times we witness those who are inspiration to those around them for their efforts in preserving our heritage. This young man was excited to receive a national certificate and a new certificate from our camp. Sure he and others like him would love to also be a member of our division.

The Majority Rules (Judges Chapter 6&7)

Chaplain of the Army of Trans Mississippi in November of 2011.

It has often been said and often repeated that, "One man and God is a majority." This is true since God alone is a majority. God has never needed great numbers to accomplish His purpose. Consider the story of Gideon as told in the book of Judges.

The land of Israel was being oppressed by great hordes of Midianites and Amalekites. Under God's direction, Gideon sent out a call to arms throughout Israel, but only 32,000 responded. God told Gideon that it was too many, and the number was reduced to10,000. Again God said it was too many and ultimately reduced Gideon's force to a mere 300 men. Gideon and his small band were victorious, and the vast army of the oppressors were totally destroyed!

The point is, without God 32,000 Israelite soldiers would not have been nearly enough. But with God 300 was a majority, and the majority rules.

In his first letter to the church at Corinth, Paul writes, "God hath chosen the weak things of the world to confound the things which are mighty," (I Cor. 1:27b). Then in verse 29, he explains why: "That no flesh should glory in His presence." Again, God alone is a majority.

Today the Sons of Confederate Veterans face many challenges. We are challenged to recruit and retain members, which should be a priority to each of us. We are challenged to carry out the Charge delivered to us by General S. D. Lee more than a hundred years ago, which should be our defining characteristic. And this we will do. But like Gideon, we are confronted by great hordes of oppressors.

There are many who would tarnish the memory of our brave and noble Confederate fathers and deny them their honor, and who would reduce our proud Southern heritage to a legacy of shame. And perhaps as Gideon, we may wonder how we can be successful against the determined forces that beset us. But, we can succeed if we put our faith and trust in God, and seek His guidance and direction, because God is a majority, and the majority rules.

However, as God gives us strength, direction and success, we must remember why we succeed. We must remember that with God, we the Sons of Confederate Veterans are a majority, and in so doing we will prevail against all those who oppose our just and most worthy Cause.

Recently, the Division has come under fire from members of the press for placing a mega flag in honor of General Nathan Bedford Forrest. Naturally, we took issue with that and produced the following statement. I hope you will enjoy reading this defense of the good General as much as I enjoyed writing it and sending it out:

Since the placement of the General Nathan Bedford Forrest Memorial Flag Site in Burke County, the *Morganton News Herald* has insisted on tarnishing the legacy of General Forrest and along with it, the reputation of the North Carolina Division, Sons of Confederate Veterans.

It is wholly incorrect for the News Herald to state General Forrest was a "former KKK leader" or a "Ku Klux Klan leader." Their statement of falsehood as fact implies the North Carolina Division, Sons of Confederate Veterans is honoring a Klan leader. This is completely false.

The defamatory rumor General Forrest was in any way involved with the early iterations of "the Klan" (as it is now widely known) first appeared in the years following the War Between the States. As is well established, the Klan was not a singular organization, but rather, the public's conception of a number of

different organizations dedicated to racial violence and Democratic-party rule in the years following the War Between the States. There were several such societies and organizations across the South during the days of reconstruction, however, the Klan which is most often referenced began in Pulaski, Tennessee in late 1865 and was called the "Kuklos." What the public now thinks of as the Klan, was actually a consolidated and re-organized version of these various groups, named the Ku Klux Klan, which appeared around 1915 and had chapters and supporters North and South. This Klan used the United States flag as its symbol and not the Confederate flag.

One of the most persistent and false rumors is the claim General Forrest was elected "Grand Wizard" of the Klan in 1867. As it turns out, he was not even present at this particular meeting, and while elected in absentia, never served or agreed to serve in any such capacity. There is some evidence to suggest the nomination and election was intended as a Klan sneer at his progressive postwar statements on race relations in the South.

General Forrest was called before a Congressional committee in 1871, and for four hours, under oath, gave testimony confirming that he was not and had not been a part of the Klan. In his own words, when asked about the Klan, General Forrest stated: "It was a matter I knew very little about. All my efforts were addressed to stop it, disband it, and prevent it...I was trying to keep it down as much as possible." Further, he added: "I talked

with different people that I believed were connected to it, and urged the disbandment of it, that it should be broken up." This is all part of the congressional record of the United States and can be easily confirmed. During those same proceedings, the only evidence presented by members of Congress to corroborate General Forrest's connection with the Klan was an article from a Cincinnati newspaper.

While there is plenty of documentary evidence to refute what the Morganton News Herald states as fact, there is far less evidence to support its conclusions. In reality, General Forrest was a brilliant military leader, and after his service to the Confederate States of America, a model citizen of the re-United States. His efforts after the War included reconciliation with the Northern states and several public statements supporting the equality and success of African-Americans. This was done with courage and at the expense of General Forrest's image among some of his contemporaries.

As a testament to his feeling, he addressed the Independent Order of Pole Bearers in Memphis in 1875, saying: "I came here with the jeers of some white people, who think that I am doing wrong. I believe I can exert some influence and do much to assist the people in

strengthening fraternal relations and shall do all in my power to elevate every man, to depress none." He also said: "Many things have been said about me that are wrong, and which black and white persons here who stood by me through the war can contradict...I feel that you are free men, I am a free man, and we can do as we please. I came here as a friend and whenever I can serve any of you I will do so. We have one union, one flag, one country; therefore, let us stand together. Although we differ in color, we should not differ in sentiment."

Vilifying General Forrest is wrong. He is worthy of our praise and led our ancestors by example through four terrible years of War against an oppressive federal government. When that struggle was over, he made it his life's work to be a good citizen of the reunited nation and to embrace all of those who shared his values. We encourage the *Morganton News Herald* to retract its former statement and acknowledge that there is far more to the story than their previous coverage would indicate.

The bottom line is that insults to men like General Forrest are taken for granted by the media and the general public because they have been brainwashed. When I set out to defend General Forrest, I had only looked into the issue of his

"klan involvement" a few times and wasn't really sure what I'd find. I was shocked to find just how thin the connection, often stated as irrefutable fact, was and is. There is literally NO solid evidence to suggest that General Forrest was a member of "the klan" or "a klan" and he certainly was not a "Grand Wizard." There is some issue about his issuing an order dissolving the klan in 1869 (i.e. how could he issue such an order unless he was in charge?), however, I was hard pressed to find the actual source of such an assertion. Like the liberal agenda behind General Forrest's coordinated character assassination, it was a bunch of crap, made valid in the public mind only because it has been wrongfully repeated so many times. Fiction can become fact if enough people hear it, believe it, and pass it on and that is what keeps the left and their culture war against us alive and well.

Thank you for your continued dedication to the Division and your support in my position as Heritage Officer over the years. I look forward to serving in my new capacity and helping the Division continue its growth into a viable, 21st century organization that will survive another century.




