\$1000.00 CHALLENGE GRANT

The day following our annual meeting, we received a check from the State of North Carolina, Department of Cultural Resources, Division of Archives and History. "Regional History Sites Program Grant" must be used for the "General Development of Public Attractions Program in Southport."

The Executive Board has budgeted matching funds and has accepted the challenge. With so many things that can and possibly should be done with this limited amount of money, and with the State regulations on grant expenditures; it is a real challenge to spend your money on worthwhile projects. We hope to be able to promote the Southport Historical Society and do something constructive for the heritage of Southport.

SOUTHPORT HISTORICAL SOCIETY reported by Abbie Bitney, C.G.R.S.

The Southport Historical Society issues a <u>Century Family</u> <u>Certificate</u> and a <u>Pioneer Family Certificate</u>.

Any person whose family has lived in Brunswick County for at least 100 years or more is eligible for a Century Family Certificate. This is a good way to honor your family, or the family of a friend who may not know about our project. The Certificates are Gold Leaf, suitable for framing. It shows the name of the descendant as well as the ancestor. You are requested to prove that your family lived in Brunswick County by 1890, but that difficult with copies of the U. S. Census for the 1880 Brunswick County available so many places in this area. Look up your family in this census, make a note of the page number, and line number where they are listed and copy the recorded information listed on the family. You must then complete an application for the certificate. The cost is \$10.00, with the profit going into the Historical Society Cemetery Endowment Fund. Tax lists and land records are other ways to prove the family residence in Brunswick County for 100 years.

The <u>Pioneer Family Certificate</u> is more complicated. You must prove your family's residence in North Carolina prior to Statehood, 1787. You must furnish the information that proves the connection to the pioneer family.

Please send a long stamped return envelope to the Genealogy Committee, Southport Historical Society, 501 N. Atlantic Ave., Southport, NC 28461 and ask for an application. You may copy the application if you want more than one certificate. We want an application and its information, but no need to furnish duplications in proofs.

Brunswick Community College, Learning Resource Center, is making a collection of photo copies of family histories or other information that was recorded in Brunswick County Family Bibles. Two copies of the records are made of each of the pages of writing on Acid Free Paper. One set of the copies will be presented to the owners of the Bible, for their own use and safekeeping. The other copy will be placed in a reference section of the Learning Center and made available to researchers seeking to trace their family roots. NOTE: A copy of the following article was given to the History Page Editor many years ago by C. Ed. Taylor, a prominent attorney in Brunswick County from about 1898 until his death in the 1940's. On the back of the copy which he gave me he had written, "Noble Expression by Citizens of Brunswick County". That is what I have chosen to call it for the newsletter.

"NOBLE EXPRESSION BY CITIZENS OF BRUNSWICK COUNTY"

(FROM THE RECORD OF THE COURT OF COMMON PLEAS AND QUARTER SESSIONS)

NORTH CAROLINA

:

DECEMBER TERM 1866

BRUNSWICK COUNTY

The Grand Jurors of the County of Brunswick aforesaid present to the Court now in session that they deem it proper at this time to give expression to their unanimous opinion upon a question which vitally affects the interest and honor of the State of North Carolina. They refer to the question of Repudiation. They bring themselves to believe that any considerable number of people of this state favor the repudiation of private or public debts, but there are those who have unadvisedly agitated this question. The Grand Jury desire to promulgate as the sentiment of the people of the county of Brunswick that every debt of the State as well as the citizens thereof should be honestly discharged. They are sensible that the terrible ravages of war and the loss and destruction of property resulting therefrom have greatly impaired the means of our people and consequently their ability at present to meet promptly their obligations; but the war has left our honor impaired and this we cannot consent to surrender.

The Grand Jury impressed with the great importance of the subject, and charged as they are to inquire into all matters affecting the welfare of the county, feel themselves called upon to make this presentment of their views, being satisfied that if the people of the State had it in their power to repudiate their debts and contracts that such a policy would be ruinous and destructive of their best interest and remain a standing reproach to North Carolina.

They trust the Legislature may be able to afford to the debtor some relief by allowing him time to discharge his obligations, but they believe the public interest will be subserved and the public credit to a great extent restored by a declaration of that honorable body that under no circumstances will North Carolina repudiate her debts and that every obligation assumed by her shall be fully performed.

It was ordered by the Court that this presentment made by the Grand Jury should be received by the Court and by them ordered that it should be spread upon the minutes of this Court, together with the names of the Grand Jurors who presented the same:

On Page 1 of the same I find that there were present holding the said term:

Also, Rufus Galloway was sheriff, and returned a venire of 30 men, from which the above fifteen were drawn as the Grand Jury

NOTE: I am indebted to Francey Wertz for securing the following information about "repudiation" for us:

(Public Debt) The states have the right to repudiate debts if they wish since they have inherent sovereign powers. On two occasions, the most significant being in the South after the ousting of the carpetbagger governments following the Civil War, states have repudiated debts outright. Local governments technically are corporations and not sovereign governments, have no sovereign powers and thus can be sued and cannot repudiate debt.

(N C.) The Convention of 1865 repealed the ordinance of secession, declared slavery abolished, repudiated the state war debt, and scheduled elections for the establishment of a constitutional state government. Jonathan Worth, the elected governor, was an honest and capable official, but the government established shortly thereafter in accordance with the views of Congress was corrupt, inefficient, and tyrannical.
