Robert E. Lee Celebration honors four US Veterans at State Capitol ceremony

RALEIGH—Four US Armed Forces Veterans were honored at the 28th Annual Robert E. Lee Birthday Celebration at the NC State Capitol on January 21, 2017. Approximately 200 people were in attendance for a standing-room only ceremony. Retired NC National Guard Brigadier General Gary Pendleton delivered the keynote address as the Stars and Bars flew over the capitol dome.

Senior Airman Michael Cooper, US Air Force (Ret.) was awarded the MOSB and SCV War Service Medals. Lieutenant Darwin Roseman, US Army (Ret.) was awarded the MOSB Southern Cross of Honor. Past North Carolina Division Commander Caudill Passes

Jack Leon Caudill, Jr., 81 of McLeansville, passed away on January 31, 2017, in Greensboro. Jack served as Commander of the North Carolina Division SCV from 1968-1971. Commander Caudill was instrumental in the reorganization of the North Carolina Division in the late 1960s. He was a member of the Colonel Charles F. Fisher Camp 813, Graham, until very recently when his health declined.

A funeral service was held February 6, 2017, at Calvary Baptist Church in McLeansville. Interment followed at Glencoe United Methodist Church with full military and masonic rites.

Jack was born on January 6, 1936 in Wake County, NC, to the late Jack Leon Caudill, Sr, and Estelle Williams Caudill. He served in the US

Army (1954-56) as part of the Occupational Army in Germany during that era of the Cold War. He was retired from the Guilford County Sheriff's Office and taught Criminal Justice for several years at G.T.C.C. for incoming Police, Sheriff and Correctional Officers. Jack was a Past Master of the Tabasco Masonic Lodge # 271 A.F. & A.M. in Gibsonville, NC and was also a member of the Burlington Shrine Club and their AMRAN Fire Brigade. He was a longtime member of Calvary Baptist Church, and was active in his church community. Following the Civil War Centennial, Jack joined the Sons of Confederate Veterans and was one of the leaders who helped reestablish the North Carolina Division.

He is survived by his wife of 54 years, Elisabeth Beal Caudill, daughter Jacqueline Caudill DePoli (Daniel), son, Perry Charles Caudill (Tracie), a brother, Stephen Caudill (Betty) grandchildren, Dominique DePoli, Christopher Caudill (Courtney), Nicholas Caudill and Mattie Caudill, great grandchildren, Ava and Kinley and numerous nieces and nephews.

Our Flags Will Fly!

Once again, for the 29th continuous year, on Saturday, March 4, 2017, the North Carolina Division, Sons of Confederate Veterans will celebrate Confederate Flag Day in the historic North Carolina State Capitol in Raleigh, North Carolina.

Over the years Confederate Flag Day has been celebrated by the NC Division with some tremendous programs and excellent and inspiring speakers, including Dr. Clyde Wilson, Chief Justice I. Beverly Lake Jr., Dr. Donald Livingston, Dr. Paul Gottfried, Dr. Samuel Francis, and others. And this year will be no exception.

Mr. Paul C. Graham will highlight the program. The topic of his presentation will be: “Honoring Our Fathers.”

Mr. Graham hails from South Carolina, and holds both a BA and an MA degree in philosophy from the University of South Carolina. He is an instructor in philosophy. He is a rousing speaker, and has partnered with Dr. Clyde Wilson in founding and running The Shotwell Press, which has become a leading publishing house for books defending the South. He has written articles and reviews for numerous publications, including *The Simms Review*, *The Palmetto Partisan*, and *The Abbeville Institute*. During the political firestorm following the Charleston shootings back in 2015, he was an island of reason and sanity defending our flags and symbols.

Ceremonies for Flag Day will begin at 1 PM on Saturday, March 4, in the historic House of Representatives chamber in the Capitol. A color guard will escort our flags to the well of the House—the same chamber where North Carolina adopted the Ordinance of Secession in May 1861. Ellis Selph and his band will provide period and patriotic music. All SCV members and friends are urged to attend this memorable event, as well as to publicize it in your camp newsletters. Compatriots, please make plans to attend, and bring you families and friends. This event should be inspiring and also educational.

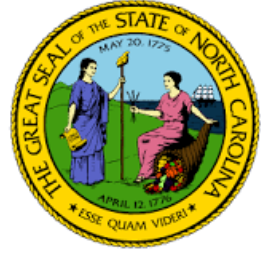
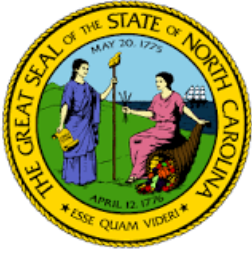

Below you will find excerpts from my New Year's address to the Division and my report from the Winter DEC meeting. I am including them here for the benefit of those who do not receive e-mails and who were not able to attend the DEC.

It is IMPERATIVE that we be able to communicate quickly with division members. We can only fight if we use the same tools as our enemies. E-mail is the most basic of these tools. All I can say to those of you who "don't do e-mail" is "JOIN OR DIE." I only mean "DIE" in the sense that your non-participation will kill our organization.

We just came from a very successful DEC meeting and I thank the Smithfield camp for their superior efforts in organizing the event. More than 120 members attended and that is a very good step in the right direction.

Please look forward and plan on attending Flag Day at the State Capitol on March 4th at 1:00 PM, and our Division Reunion on April 29th at 10:00 AM in Maggie Valley. We are coming up on Memorial month as well and the Spring will be a very busy time for all camps across the state. Be sure to get the information out about your camp's activities and

maximize attendance wherever possible. Here are the excerpts from my recent remarks:

New Year's Address:

The new year has me thinking about several things including the many exciting projects and Division objectives we will be completing this year. Most of all, however, I am thinking about the parallels between our current state of affairs and that of our ancestors.

In current times, as well as those leading to the War Between the States, hypocrisy is what we see more than anything else. The Declaration of Independence of 1776 is celebrated but the same concept employed by our ancestors in 1861 was "treason." The same people who call our ancestors traitors and whose ancestors spilled blood in the name of "Union" have legitimized "#CalExit" and the modern liberal secession movement. Black Americans who sympathize with us are treated as aberrations and fools because they refuse to subscribe to the false beliefs the Democratic party would prefer them to have. Syrian muslim refugees are afforded more respect and deference by the establishment than our own ancestors in this country. Our ancestors built the world we live in today and afforded us the freedoms and privileges we enjoy yet they are treated with contempt by academia, the media, and the establishment. The list goes on and on and is nothing but bald hypocrisy. We are constantly affronted and detested all in the name of a perverse culture war being waged to turn this country into a failed social experiment. We are surrounded by

My reports indicate that they are reorganizing and getting things organized for a busy year of making new alliances. A majority of the candidates supported by the PAC were elected or reelected. Most importantly, Steve

Troxler was reelected and this will hopefully ensure that we continue to be allowed a booth at the State Fair. However, North Carolina's heritage lost a valuable ally in the defeat of Rep. Gary Pendleton who narrowly lost his election. The PAC also supported Attorney General candidate Buck Newton who lost his bid for election and would likely have been another helpful ally. Regardless, I know you will be seeing more from the PAC as the year progresses and contributions start flowing again. While the SCV is not a political organization, it is important that we individually support organizations like the PAC who look out for our ancestors. They will be concentrating heavily on fundraising outside of our organization as financial support from our members has all but dried up. This is another area in which leading by action rather than words is important...before you ask "why isn't the PAC doing more?" be sure to ask first if you have contributed. If you have not, it is your duty to do so whether by offering your services or making a donation.

Again, we have many exciting projects to tackle as a Division this year but we cannot make them successful without your participation. Let this be the year that we all come forward in the name of our ancestors and honor them in the way they deserve to be honored.

Executive Council Report:

I am excited to bring good news of hard work and steady movement forward on Division projects since the last DEC in August. The bottom line is that I am pleased several peo-

ple have stepped up and put their duty to their ancestors above all else. However, we all know times are tough for Confederate heritage and we need even more of you to come forward and offer your time and talents. I cannot stress that enough.

Currently, we are in need of members who are skilled in social media, specifically Twitter. If you or someone you know can be of service, please get in touch with me. Our 2nd Lieutenant Commander, Andrew Johnson, has done a fantastic job of keeping our Division Twitter account active, however, he is responsible for a million other things and we want someone to start using our Twitter like Donald Trump. We need someone who can constantly monitor the Twitter community and respond, retweet, and produce hashtags that advance our cause and increase our exposure and relevance. Please let me know if you have any ideas.

In other news, our new Quartermaster, Darwin Roseman, has taken on the serious task of re-vamping and re-introducing the Division Store. In his capable hands, we aim to use the store to increase revenues and provide Confederate heritage-related items to members and the public that are currently in high demand. As that project rolls out, you will be hearing more.

Related to that, we are excited to offer "Support Confederate Heritage" stickers for \$20 per roll. We would like camps to purchase these for distribution at public events. If you have any interest, please contact me and we will get you some.

We will not pay or charge you for shipping—any orders must be paid for in full at the time of purchase by cash or check. If an order requires delivery, I will have the applicable Brigade Commander deliver them to the ordering camp in person rather than shipping them. The stickers will also be available at the Division Reunion in April for purchase in person.

Our Division Headquarters is still coming along and I will be scheduling a Division workday in the near future before it gets too warm. An announcement will go out over the Tarheel listserve so be on the lookout. It is my goal to try and incorporate headquarters into our Division activities as much as possible and in order to accomplish that goal, the house and grounds will require some work on our part.

That reminds me, if you are not on the Tarheel list, you need to be. I know many of you are hesitant to use e-mail or do not want to receive a bunch of junk e-mails. Regardless, if we are to be an effective organization, our members need to know what is going on firsthand. You need to receive these e-mails so you can better participate. It is easier to delete e-mails you do not want than to be out of the loop.

I am happy to report our budget is very strong right now. As you can see from Danny's handout in the agenda, our dues increase has resulted in significantly increased revenues. Just as I explained when I proposed the increase, this will allow us greater financial freedom. We can fund worthy projects and enjoy fewer limitations concerning

the defense of our heritage. This will mean more monuments, more mega flags, and being able to honor our ancestors in the manner they deserve.

Our Brigade Commanders continue to participate in monthly conference calls with 2nd Lieutenant Commander Johnson and myself. As Southern gentlemen, none of them do what they do as members for personal recognition because we all know it is never what any of us do, but it is what our ancestors did that matters. As this moment while completing this column, I am in Montgomery, Alabama, and have spent another day working in view of the Confederate Monument at the Alabama State Capitol. The First National, Second National, Third National and the Battle Flag are no longer flying on each corner of this monument since my last time in the First Capitol of the Confederacy, but it is still inspirational to be in this historic place.

So many years later it makes you appreciate those before us who erected our monuments and reflect on the words of General Stephen D. Lee in his 1906 address in New Orleans published in the Confederate Veteran.

As always, I especially thank you again for all you do in vindicating the cause for which he fought, defending the Confederate soldier's good name, commitment to the guardianship of his history, emulating his virtues, perpetuating those principles he loved and living those ideals that made him glorious which you also cherish.

I want to cover two major topics in this column: dealing with the media and

the North Carolina Heritage PAC.

First, as I have said countless times, the media is not our friend. Despite thoughts about free publicity and getting our message out, if the past has taught us anything, it is that no matter what, our message will be distorted and the facts will be stated in such a way that we look like idiots and bigots despite our best efforts.

In January 2017 that is ESPECIALLY true. Like him or not, the media's handling of Donald Trump since he came onto the political stage has clearly shown its blatant bias and subversive agenda. I saw one study recently which stated that of the members of the national press who donated to political campaigns in the last election cycle, 98% of them donated to Hillary Clinton. This isn’t just done in reporting the news either. TV shows, movies, and even commercials highlight the “dumb dad” and the “redneck slob” while glorifying and beautifying transsexuals and pop stars.

This is all done very subtly too. You’ll notice when reading articles, especially in local news: numbers of protesters are “massaged” (1,000 at an anti-immigration rally...“a dozen” at a flag rally) depending on the viewpoint of the protestors; to encourage participation, times and places are announced AHEAD of time for leftist marches while our ceremonies and rallies are reported disparagingly AFTER the fact; words like “racist,” “hate,” and “slavery” are used in articles describing our efforts while words like “justice,” “protest,” and “compassion” are used in articles describing the efforts of organizations like the NAACP. The list goes on and on and each subliminal attack seeps further and further into the subconscious of American public thought.

And what do we do? We continue to watch and participate in the narrative which has successfully encouraged the destruction of our national society and has turned us into punchlines. Well, as far as my responsibilities in the Division are concerned, NOT ANYMORE. There will be no more dealing with the press and hoping they get it right. They won’t anyway. If another

Confederate flag crisis arises and we are inundated as we were in the summer of 2015, DO NOT talk to the cameras, DO NOT respond to reporter e-mails, DO NOT respond to Facebook messages. For my part, I will tell members of the media they are the scum of the earth and cannot even be trusted to report the details of a traffic accident truthfully. We will not play their game anymore. If something must be said, it will be said carefully and only if there is some advantage for us. That is why we will be improving our presence on Twitter, following the President’s example and communicating directly to the public rather than depending on a false messenger.

The SCV is not a political organization. Our ONLY concern is the protection of the legacy of our Confederate ancestors. However, while we generally have scarce political allies in either party, we certainly have NONE on the political left. As long as the media participates in their current farce of “journalism,” they will be counted among our enemies.

On the PAC, I want to distribute a few reminders. The most of important of which is that the North Carolina Heritage Political Action Committee is a completely separate organization and entity from the North Carolina Division, Sons of Confederate Veterans. The leadership is different, the PAC is funded independently, and the NCSCV exercises NO control over the PAC. The PAC was formed by individuals, who also happen to be members of the NCSCV, as a private effort to forward the cause of protecting

NORTH CAROLINA’S heritage to the state legislature.

This is important to note because the NCSCV must and shall remain non-political. As a non-profit organization, we do not endorse candidates for office or political parties. The PAC, however, can. This is because the PAC’s efforts are orchestrated by individuals, some of whom happen to be SCV members, in their private capacity. When speaking of the PAC, there is no “our” or “ours.” It is 100% separate and self-autonomous. Please remember that in your comments within and without the SCV. What this means is the PAC depends on your support as private individuals. However, I can say without hesitation that the PAC is a worthy cause and if it does receive sufficient financial support, will astound you with what it is able to accomplish politically. Please consider contributing or continuing to contribute so that it can realize its full potential.

While Confederate heritage is the main focus of the PAC, I think we all realize it is not only Confederate history under attack anymore. Andrew Jackson and Charles B. Aycock are two examples of great men who contributed much to our state who are currently being attacked, defamed, and erased from history. It won’t be long before radicals have us all believing World War II vets were international interventionists and Vietnam vets were war criminals. The PAC is designed to combat these trends.

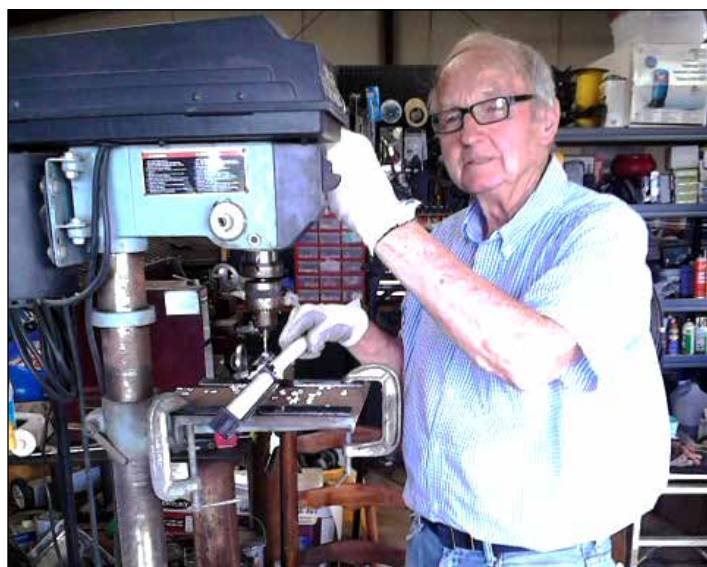
