


Draft Lesson Plan

Training Objectives:

- Demonstrate the ability to recognize human trafficking violations.
- Demonstrate the ability to recognize victims of human trafficking.
- The ability to identify different types of human trafficking.
- Demonstrate the ability to identify “red flags” that may indicate the presence of labor or sex trafficking.
- Exhibit interviewing techniques that are sensitive to the needs of the victim.


- Demonstrate the ability to understand different cultural groups.
- Demonstrate the ability to provide the necessary resources for victims.
- Demonstrate the ability to properly document and report human trafficking cases.
- The ability to prepare comprehensive case files to prosecute violators.
- Demonstrate the ability to research both State and Federal Statutes to determine proper charges.
- To develop a basic understanding of Immigration and Customs laws and procedures.
- Provide the student with follow-up procedures to ensure safety and confidentiality of victims.
