### **LOOKING BACK - THE HISTORY PAGE**

Since we are in the midst of a political campaign, I thought this article written in 1896 by John T. Drew to the Editor of The Wilmington Messenger would be of interest. Mr. Drew has some interesting ideas about war, marriage and family, the role of newspapers, as well as

politics! Clearly the financial woes of Brunswick County are nothing new. Note that Mr. Drew was 57 years old when this was written. This article is from the files of Bill Reaves.

#### Letter to the Editor:

I was born in Brunswick County, North Carolina, nine miles from old Smithville, now Southport, then and now the county seat of said county, on the 1<sup>st</sup> day of January, 1839, of poor, but honest and highly respectable ancestors, this being the poorest spot in that State, county or civil district and also the poorest township, range or section of the State or county. I was schooled about nine months at intervals in the public schools of that noble old North State.

I was the first volunteer from that county although opposed to secession. I soldiered through the unpleasant situation as much as my physical condition would permit, Dr. F.W. Potter and other eminent medical men furnishing certificates for me to remain at home with a widowed mother and several dependent brothers and sisters. I was surrendered or disbanded at Raleigh, NC, being a remnant of Col. J.G. Burr's command of State Guards from Wilmington, with Capt. Billie Bellamy's company. In our camp at Raleigh the Hon. Governor Z.B. Vance was a daily visitor. On Gen. R.E. Lee's capitulation, we were disbanded, and I tramped from Raleigh, via Fayetteville, with three other comrades to my mother's home, on Town Creek, seven miles from your hospitable city. I lived, stayed, and existed two or three years in that innocuous destitution, and, to relieve the situation, married.

'Twas not long for me to see for myself the necessity of a more congenial clime and more productive soil. I came to this, Hickman County, Ky., arriving at Columbus on the 23<sup>rd</sup> day of December, 1869. I have studied and practiced various occupations. I was admitted to the practice of law in 1873, having been burned out in my mercantile business. I have since performed all kind of labor with these hands, and am now old and cannot write, but during all vicissitudes of life I have never followed any creed, faction, ism or side track from the main line of true Democracy, and today I am an honest sound money Democrat, with men of national reputation, as McCreary, Carlisle, Cleveland and many others whose principles are undying and unchangeable.

I left many relatives and friends in the Old North State and am surely grieved to hear and know that some have gone to the Populist and some to the Republicans .... Judge D.L. Russell, I see, is likely to be Governor. Old Brunswick County should unite her Democratic forces and attend to that little matter. He was a friend of mine, but a Republican.

I read your paper with much interest and hope to see you give more space to men of your locality and especially from the poor old county of my nativity. Write an item from old Fishing Creek near the Wescott and Drew settlement and from old Lockwood Folly. Make your paper replete with news and in advance of the old regimen which once invaded your locality.

#### IN SYMPATHY...



### SHS BOARD MEETING HIGHLIGHTS

 Jail: Welding, heating and AC bids are being received and reviewed. Special meetings are being set as needed to meet with contractors to discuss their bids. The board approved seeking professional advice on the structural integrity of the building before the H/AC is installed.

- SHS agreed to work with UNCW Archives to have our historical videotapes placed in their files.
- SHS agreed to publish a history of the USS Gill written by a UNCW student.
- SHS Board agreed to hold its general meetings at the Community Building in 2003.



## **CEMETERY ENDOWMENT FUND**

During a board meeting on January 21, 1987, Abbie Bitney, chairman of the Cemetery Committee, suggested starting a trust fund for cemetery maintenance, with "interest used for repairs, and the principal untouchable." On April 2, 1987, the *Cemetery Endowment Fund* came into being with an initial investment of \$25. It is now known as the Abbie

Bitney Cemetery Endowment Fund.

In a letter to members of the Historical Society, Abbie Bitney emphasized that the monies the fund generated were to be used "for the preservation and professional restoration of some of the old markers and monuments in the Old Cemeteries of Southport." She goes on to say that "the interest ONLY from the Cemetery Endowment Fund will be used for major maintenance and repair . . . The capital of the Fund will NOT be spent, so preservation of the Old Cemeteries of Southport will be financially secure."

The board of directors and officers of Southport Historical Society have honored this commitment, and the Fund has since grown to over \$5,000. Total earnings over the years from the Fund were \$2,875.81 at year-end 2001. To my knowledge, only one draw has been made from the earnings. In February 2001, \$672.00 was made available to the Veterans of Foreign Wars to purchase flag holders for graves in the cemetery. The Fund continues to grow from donations and an annual transfer of profits from the sale of the book *Cemeteries of Southport*.
