

Bastian Family – Generation 1

<u>MICHAEL BASTIAN</u> was born about 1690 in Germany. He married Eva Maria Geigers on 27 Feb 1714 in Durrn, Pforzheim, Baden, Germany (Evangelische Kirche Durrn). She was born about 1690 in Germany. Michael Bastian and Eva Maria Geigers had the following children:

- i. **ANNA MARIA BASTIAN** was born on 25 Sep 1715 in Durrn, Pforzheim, Baden, Germany.
- ii. **JOHANN MICHAEL BASTIAN** was born on 14 Mar 1719 in Durrn, Pforzheim, Baden, Germany. He died in 1765 in Lehigh, Pennsylvania, USA. He married Anna Magdelena Beckerin on 04 Jan 1746 in Evangelisch, Berghausen Durlach, Karlsruhe, Baden. She was born in 1721.
- iii. **MATTHIAS BASTIAN** was born on 20 May 1723 in Durrn, Pforzheim, Baden, Germany. He died on 03 Dec 1803 in Rowan, North Carolina, USA (burial was this date). He married (1) ANNA BARBARA MARTIN on 03 Dec 1748 in Niefern, Baden, Germany. She was born on 15 Dec 1725 in Germany. She died on 05 Oct 1751 in Philadelphia, Philadelphia, Pennsylvania, USA (10 days after arriving in America.). He married (2) ANNA CATHARINA DILLINGER, daughter of Henrich Wilhelm Dillinger and Anna Rosina, on 18 Feb 1752 in Lehigh, Pennsylvania, USA (Upper Milford Lutheran Church).
- iv. **JONAS BASTIAN** was born about 10 Mar 1726 in Durrn, Pforzheim, Baden, Germany. He died about 1805 in Rowan, North Carolina, USA. He married Margaretha Becker on 15 Oct 1752 in Lehigh, Pennsylvania, USA (Upper Milford Lutheran Church).
- v. **ANDREAS BASTIAN** was born on 27 Jul 1729 in Durrn, Pforzheim, Baden, Germany. He died about 1784 in Rowan, North Carolina, USA. He married Magdalena Unknown in Red Hill, Montgomery, Pennsylvania, USA.

JOHANN MICHAEL BASTIAN was born on 14 Mar 1719 in Durrn, Pforzheim, Baden, Germany. He died in 1765 in Lehigh, Pennsylvania, USA. He married Anna Magdelena Beckerin on 04 Jan 1746 in Evangelisch, Berghausen Durlach, Karlsruhe, Baden. She was born in 1721. Johann Michael Bastian and Anna Magdelena Beckerin had the following children:

He married (1) ANNA BARBARA MARTIN on 03 Dec 1748 in Niefern, Baden, Germany. She was born on 15 Dec 1725 in Germany. She died on 05 Oct 1751 in Philadelphia, Philadelphia, Pennsylvania, USA (10 days after arriving in America.). He married (2) ANNA CATHARINA DILLINGER, daughter of Henrich Wilhelm Dillinger and Anna Rosina, on 18 Feb 1752 in Lehigh, Pennsylvania, USA (Upper Milford Lutheran Church). Matthias Bastian and Anna Catharina Dillinger had the following children:

- i. ANNA ROSINA3 BASTIAN was born on 27 Oct 1752 in Lehigh, Pennsylvania, USA.

JONAS BASTIAN was born about 10 Mar 1726 in Durm, Pforzheim, Baden, Germany. He died about 1805 in Rowan, North Carolina, USA. He married Margaretha Becker on 15 Oct 1752 in Lehigh, Pennsylvania, USA (Upper Milford Lutheran Church). Jonas Bastian and Margaretha Becker had the following children:

- i. MATTHAIS3 BASTIAN was born on 10 Oct 1753 in Lehigh, Pennsylvania, USA.
- ii. PHILIP BOSTIAN was born in Jan 1755 in Lehigh, Pennsylvania, USA. He died in Rowan, North Carolina, USA. He married ELIZABETH.
 - iii. JONAS BASTIAN was born on 11 Aug 1756 in Lehigh, Pennsylvania, USA.
 - iv. CHRISTOFF BASTIAN was born on 23 May 1760 in Lehigh, Pennsylvania, USA.

<u>ANDREAS BASTIAN</u> was born on 27 Jul 1729 in Durrn, Pforzheim, Baden, Germany. He died about 1784 in Rowan, North Carolina, USA. He married Magdalena Unknown in Red Hill, Montgomery, Pennsylvania, USA. Andreas Bastian and Magdalena Unknown had the following children:

- i. ANNA CATHARINA3 BASTIAN was born on 17 Jan 1759 in Lehigh, Pennsylvania, USA.
- ii. JOHANN PHILIP BASTIAN was born on 10 Jun 1760 in Lehigh, Pennsylvania, USA.

Bastian Brothers of Durrn, Germany and Rowan County, NC

German church records document the ancestors of many Bostians that live in Rowan County and other areas of North Carolina today. Copies of these church records were recently found at the Family History Library in Salt Lake City, UT by Klara Petersen, another Bastian researcher. I have not personally reviewed the original records but have seen a transcript of the records, which provide important new information on the ancestry of this family.

Records of the Evangelical Church in Durrn, Baden, Germany (FHL microfilm 1,238,493) record the birth of one daughter and four brothers, whose parents are Michael and Eva Bastian: 1) Anna Maria Bastian, b. 25 September 1715; 2) Johann Michael Bastian, b. 14 March 1719; 3) Mathias Bastian, b. 20 May 1723; 4) Jonas Bastian, b. 10 March 1726; and 5) Andreas Bastian, b. 27 July 1729. Records of the Evangelical Church of Berghausen, Baden, Germany document the marriage of Johann Michael Bastian to Magdalena Beckerin on 04 January 1746. Records of the Evangelical Church of Niefern, Germany document the marriage of Mathias Bastian to Anna Barbara Martin on 03 December 1748.

Today the municipality of Olbronn-Durrn (population approx. 3400) is in the District of Enz in Baden-Wurttemberg and is approximately 27 miles northwest of Stuttgart. This is in southwest Germany near the Rhine River. According to Wikipedia, the present day Evangelical Church of Durrn contains the nave, which was built in 1738. The church is a protected national monument.

These four brothers immigrated to America on three different ships between 1749 and 1752. The Ship Lydia arrived in Philadelphia, Pennsylvania 09 October 1749 from Rotterdam by way of Cowes. The passenger list of the Lydia includes Michael Bastian and his wife Anna Magdalena (Becker) age 28 with their children Christoph age 3 and Prisca age 1. Rotterdam was a frequent port of departure for German immigrants to America. The passenger list for the Lydia says that Michael and Anna Magdalena were from Berghausen, Baden, which is consistent with their marriage location. Matheis Bastian arrived in Philadelphia 25 September 1751 on the ship Phoenix from Rotterdam and Portsmouth. Jonas and Andreas arrived in Philadelphia 27 September 1752 on the ship Nancy.

"The Schoolhouse Near the Old Spring" written by Andrew S. Berky contains records of Upper Milford Lutheran Church in present day Lehigh County, PA. These records document the death of Matthias Bastian's wife Barbara, ten days after their arrival in Philadelphia and his subsequent marriage to Anna Catharina Dillinger. The book also contains birth records for 18 children of the four brothers between 1750 and 1762 as well as records showing that they supported the church financially. Included is the birth of Matthias Bastian, b. 3 March 1759, son of Matthias and Catharina Bastian, with Godparents Michael and Magdalena Bastian.

According to the "History of Lehigh County Pennsylvania", written by Charles Rhoads Roberts in 1914, Johann Michael remained in the Lehigh County area for the rest of his life. However, sometime in the 1760s or 1770s the other three brothers moved to Rowan County where their names begin to show up on tax, land, church and census records. For example, Mathias purchased land in Rowan County in 1778 and according to the diary of the Reverend Carl August Gottlieb Storch, Mathias was buried in Rowan County 3 December 1803. The 1790 Rowan County census includes Mathias Boston, Sr., Jonas Boston, and Andrew Boston and the 1790 census for Northampton, PA (became Lehigh County in 1812) includes Michael Bastian.

The "History of Lehigh County Pennsylvania" says the parents of these four brothers were Christopher and Ann Bastian, who also immigrated to America, however, it does not provide, nor have I been able to find any primary source for this information. I now believe this information to be incorrect since the Evangelical Church of Durrn marriage record for Johann Michael Bastian to Magdalena Beckerin says that his father was Michael Bastian. Records of the Evangelical Church of Durrn, Germany also document the marriage of Michael Bastian to Eva Marie Geigers 27 February 1713. It is also noted that church records contained in "The Schoolhouse Near the Old Spring" provide no information on Christopher and Ann; one would think that since all four brothers attended Upper Milford Lutheran Church their parents would likely have lived nearby and also attended the same church.

After the three Bastian brothers moved from Pennsylvania to Rowan County the surname was spelled Bastian, Boston, Bostain or Bostian, which seems to be the predominate spelling today in North Carolina. Sometime between about 1816 and 1819, Matthew Bostain (b. 3/3/1759, d. 1823), the son of immigrate Mathias Bastian, moved to Jackson County, Georgia with several of his married children and their families. Matthew's 1823 Jackson County will says his wife's name is Sarah and his children are Hannah, Jacob, Matthew, Elizabeth, Peggy, and Nelly J. Betts. From that point to today my line has used the spelling Bostain.

The records of Organ Lutheran Church in Rowan County record the birth and baptism of two of Matthew Bostain's children: Mathias Jr. and Elizabeth. There were three successive Mathias/Matthews that help us trace the genealogy of this family: Mathias Bastian (b. 1723 in Durrn, Germany); his son Matthew Bostain, Sr. (b. 1759 in Lehigh County, PA); and his son Matthew, Jr. (b. 1790 in Rowan County, NC).

Church records from Durrn, Germany, Lehigh County, PA, and Rowan County, NC provide key documentation on the ancestors of the Rowan County Bostian/Bostain families. These records also contradict the often-cited reference to Christopher and Ann as the parents of the four immigrant Bastian brothers.

THYATIRA CHURCH NEW CEMETERY SIGN WITH BROCHURE

Established by 1750 and the oldest legally documented church in Rowan County, Thyatira Presbyterian Church located at 220 White Road, Salisbury, NC is happy to announce the completion of a new cemetery entrance sign with an accompanying brochure available.

The sign contains a short history of the church and the reverse side is an alphabetical list of the older graves below the traffic circle, along with an easy to use locating system. The brochure located in a weather-proof box attached to the sign lists twenty historically significant sites, including ancestral graves of a U.S. president, tow vice-presidents, a founder of the University of North Carolina, many Revolutionary War officers, and the pirates' graves.

Thyatira hopes this sign with brochure will greatly aid the many visitors we host from across the nation and around the world as they visit our historic cemetery, often called "The Westminster Abbey of Rowan County" due to the many important people interred there.




ALPHABETICAL (LAST NAME) LIST OF BURIALS IN C

In searching for your ancestor's grave, note the names below with numbers to the left of name that row. For example, as you face the old section, row "1 west 01" is the first row of graves to you cometery with small ground level granite markets shortly below traffic circle. Grave numbers circle and continues to the back section of cemetery. In counting the grave numbers, you will traffic circle going left to right, note rows "1 west" through "7 west", followed by a small unpoint market texts face east, so morning reading is advised. A mirror or large white sheet of paper.

A GUIDE TO SOME HISTORICALLY SIGNIFICANT GRAVESTONES IN THYATIRA CEMETERY WITH AN EASY SYSTEM TO FIND THEIR LOCATIONS



"The Westminster Abbey of Rowan County"

To find these graves, refer to the numbering system at the end of each paragraph below, then read how to use the system that is on back of the brick and glass sign.

- 1. JOHN NISBET: Oldest surviving stone. First constable of area called the Irish Settlement. d 1755. 1E-43
- 2. THOMAS & NAOMI GILLESPIE: Said to be first area settlers, d. same day, Dec. 12, 1797, buried together in same coffin. Great grandparents of U.S. President James Knox Polk. 7W-35
- JOHN & JEAN GRACY KNOX: Immigrants from Scotland. 7 sons in Revolutionary War. Land grant still owned by descendants. Great grandparents of U.S. President Polk. 4W-30
- 4. THOMAS COWAN: Captain in Revolutionary War. Present nearby house built by him in 18th century according to family tradition. Only elder loyal to Thyatira in 1805 when Back Creek Church was established. Shot bear in poplar tree near home, hence the community name Bear Poplar. 7W-24
- MARY BARKLEY COWAN (1755-1836): Married to Thomas Cowan. Ancestor of Alben Barkley, U.S. Vice President during Truman administration. Also said to be an ancestor of U.S. Vice President Adlai Stephenson. 7W-23

- ROBERT GILLESPIE: D. 1760, 29 days after being scalped by Indians near Fort Dobbs. First husband of Elizabeth Maxwell Gillespie Steele. 7W-41
- 7. ELIZABETH MAXWELL GILLESPIE STEELE: Owner of Salisbury Tavern where General N. Greene spent a night during the Revolutionary War. Gave money to Greene for war effort. Mother of John Steele, 1st comptroller U.S. Treasury. Mother-in-law of Dr. Samuel E. McCorkle. She d. 1790. 7W-40
- 8. DR. SAMUEL E. McCORKLE (1746-1811): Princeton graduate, 1772. 1st installed minister Thyatira serving (1777-1805). Established Zion Parnassus Academy. A founder of University of NC. He gave the corner-stone address of the 1st building. Main campus quad. named for him. On UNC and Queens College Board of Trustees. 7W-43
- 9. COL. FRANCIS LOCKE: Revolutionary War Hero Battle of Ramsour's Mill. 3E-24
- JOSEPH KERR: Built 1822 home and 1823
 Kerr Mill, both located 1 mile west of here.
 d. 1829. 7W-54

- 11. DR. SAMUEL KERR: Son of Joseph. Home Plantation (Oakland) 2,000 acres, 100 plus slaves. Outfitted a Civil War Company. Gave ½ cost to build Thyatira present sanctuary, 1860. d. 1865. 7W-53
- 12. MAJOR JOHN LOCKE: Officer in the Revolutionary War, d. 1833. 1E-21
- 13. MATHEW LOCKE: Commander Salisbury District in Revolutionary War, Member NC Assembly to adopt Constitution. Elected two terms to U.S. Congress, d. 1801. 3E-33
- 14. FRANCIS LOCKE: NC Superior Court Equity Judge, d. 1823. 3E-23
- JOHN BRANDON: Settler, 1st Rep. elected to Colonial Assembly from Rowan County in 1754, d. 1756. 3E-37
- 16. JAMES BRANDON: Revolutionary War Colonel, killed 1781, age 18. 3E-42
- 17. WILLIAM ARMSTRONG: Captain in Revolutionary War, killed 1780, age 41. 4E-27
- 18. DR. F.N. LUCKY: Civil War Surgeon, NC Legislator, d. 1878, age 55. 3E-12
- 19. WILLIAM KNOX: NC Militia Captain in Revolutionary War. 4W-29
- 20. PIRATES GRAVES: There are no names on these 4 stones, however, 3 of them have skull & cross bones and 1 has cross bones on face. Tradition says they are pirates graves. 5E-35a, 35b, 36, 37

There are a number of Revolutionary soldiers and early settlers interred here that are not mentioned in the above paragraphs.

HISTORY OF THYATIRA CEMETERY

There was a cemetery here by 1750 according to a land record of this date. The oldest part of the cemetery below the traffic circle was once surrounded by a stone wall with an iron gate in the center of the south wall. After a stock law was passed in 1881 that all farmers must fence their livestock, the wall was allowed to fall in disrepair and the south wall was removed. The gate, handmade by Billy Cooper in 1825, was put beside a tree and forgotten for forty years. In 1925 it was taken to Davidson College to be used as an entrance to one of the college homes.

In the late 30s it was brought back and setup between two stone pillars built by the WPA. Matching pillars were built on other side of entrance and in 1978 Walter Erwin built an iron gate to match. The four pillars and matching gates make an imposing entrance to the cemetery.

Many graves are unmarked today because wooden markers have rotted and stones have broken and been tossed aside. It is thought a vast empty spot is where the third church building once stood.

Running of the North Carolina-Virginia Boundary Line

Dr. Henderson Says Historians Have Neglected to Give Due Attention To the Running of the Boundary Line of 1779-80

In the writings of North Carolina history, a great deal of attention has been devoted to Col. William BYRD and his part in the running of a portion of North Carolina-Virginia boundary line. But it is one of the many extraordinary and inexplicable omissions in our history that no attention whatever has been given to the running of the same boundary line in 1779-1780, extending westward from the point reached by Fry and Jefferson. When Col. John DONELSON ran the famous "ministerial line" in 1771-72, separating Virginia from the territory claimed by the Cherokee tribe of Indians, he ran part of the boundary line between North Carolina-Virginia westward, to the point six miles east of the present Long Island of Holston River in Tennessee. On hearing of this somewhat high-handed action from Gov. DUNMORE, of Virginia, Gov. Josiah MARTIN, of North Carolina, wrote a letter of protest to Lord DARTMOUTH in England, May 4, 1775. He charged Col. Donelson with having the "reputation of being a land jobber," and intimated that the line, as run by Donelson, was an encroachment upon Lord Granville's district. In consequence, he urged upon Lord Dartmouth the expediency of suspending the granting of lands contiguous to the boundary until commissioners from the two provinces should be appointed under his majesty's authority to determine the true boundary line.

As a matter of fact, land titles all along the supposed boundary line in present Tennessee had for some years been clouded. Many settlers had encroached upon the Indian lands and persistently refused to pay quit rents. They believed themselves to lie within Virginia, but the line, as ultimately run, proved what surveyors for long had shrewdly suspected, namely that they were living within the bounds of North Carolina. In the summer of 1777, an important treaty was held with the Cherokee_tribe at the Long Island of Holston, at which both North Carolina and Virginia were represented. Following that treaty, two of the North Carolina commissioners wrote to Gov. CASWELL, urging him to initiate steps toward extending the northern boundary line of this state.

Many circumstances pressed this conclusion upon the attention of public men in both North Carolina and Virginia. In North Carolina, the Transylvania Law Company, headed by Col. Richard HENDERSON, laid claim to some millions of lands west of this state, much of which territory would be traversed by the boundary line. At the very time, Col. Henderson and his associates were planning the establishment of a colony at the French Lick, the site of the present Nashville, Tenn. A somewhat similar situation prevailed in Virginia. The Loyal Land Company, headed by Dr. Thomas WALKER, had received an immense grant of land from the Crown in 1749. According to the strict interpretation of the original grant, made in 1749, lands lying to the north and west of the extreme western point of the boundary line were at the choice of this company; and this necessitated the westward extension of the line, to determine in which state the lands to be surveyed actually lay.

It is an extraordinary and memorable tribute to the character and integrity of Col. Henderson and Dr. Walker, heads of two great land companies and consequently with immense private interest at stake, that they were chosen, by their commissions on extending the boundary line. With such great interests at stake, both public and private, state and individual, it is not

surprising that sharp disagreements arose in the actual running of the line. Under the North Carolina Act, the commissioners appointed were Richard HENDERSON, John WILLIAMS, Caswell James KERR, William Bailey SMITH and Orandatus DAVIS. By ballot the Virginia assembly chose Thomas WALKER and James MADISON, but the latter refusing to serve, Daniel SMITH was chosen in his stead.

Following a conference with the Virginia commissioners at Williamsburg in the summer of 1779, Col. Henderson set actively to work in preparation for the arduous and dangerous task of running the line through the Indian country. He recommended to Gov. Caswell the appointment of a guard of 100 men by each colony to protect the commissioners in their work of surveying the line. On the solicitation of Col. Joseph WILLIAMS, Gov. Caswell appointed him lieutenant colonel commander of the guard, two companies of 50 men each, who volunteered for the service. The governor appointed as commissary, a difficult, indeed well-night-impossible, post to fill in a wilderness region, Maj. Samuel HENDERSON, brother of the head of the North Carolina commission. Leaving his home in Granville county on August 18, 1779, Col. Henderson, accompanied by Judge Williams and Major Smith, set out for a waste cabin on Steep Rock Creek, where he found the Virginia commissioners awaiting him on September 1.

Unable to find the bench mark for the westward point reached by Jefferson and Fry, the commissioners took the latitude from the top of a mountain, and then ran south to the latitude of the boundary line, 36 degrees and 30 minutes, where they started the running of the line on September 8, at a point agreed upon. Writing four days later to Col. Robert BURTON, his friend and neighbor in Granville, Col. Henderson says: "The delays with respect to the boundary line owing to the cloudy weather in the mountains, and the difficulty of finding where the former commissioners ended their survey, have been so great that we have only run the line about 11 miles and God knows when we shall get farther. We are now in the plain, where it is needful to be certain of our latitude, and the weather is again cloudy. From an observation made yesterday, we have to go north. This hurts the Virginia commissioners so much in their feelings that they insist for another observation, which cannot be had till an alteration of the weather. Contrary to the expectation of myself and every other person, the line will certainly leave the Long Island five or six miles south. The Virginia commissioners, Dr. Thomas Walker and Maj. Daniel Smith, who from some observations before we came, had given out in speeches that the Long Island would be miles in Virginia and thereby had blown up the inhabitants with hope of great extension of territory, are brought to bed. The people on this side the mountains from Augusta County, Virginia, and indeed farther north to this place, seem determined against the land law. They are forming committees on the occasion, in order to remonstrate to the next assembly in the strongest terms. If gentlemen will go and settle, there is no doubt of their getting a sufficient quantity of land. But not a man ought to think of speculating on land under the act of assembly."

The beginning of the disagreements between the commissions from the two states, foreseen by Col. Henderson, dates from the period September 5-10. The North Carolina surveyors, Burton and Guthrie, stated that, according to their observations, the Virginia surveyors, in attempting to rectify the error of their line by half a mile, had come two minutes and ten seconds too far to the south. To check up, Col. Daniel Smith and Col. John Williams, later joined by Maj. William B. Smith, ran the line eastward, while Henderson and Walker ran the line westward. By September 24, Daniel Smith reached the conclusion that the old line was nearly correct, contrary to the opinion of the North Carolina surveyors; and on the following day so informed Richard Henderson, to the latter's surprise.

In view of the marked difference in the observations of the Carolina and Virginia surveyors, each commission decided to run out its own line. By November 3, the two lines had diverged by the amazing amount of four miles. By November 6, the Virginia party had reached the 69 mile tree, somewhat to the east of Powell's mountain, in the continuation of their first line; and after passing over Cumberland Mountain on November 13, received a letter of protest against this line, from the North Carolina commission. Another source of disagreement was the lack of a suitable guard for the Virginia commission. On November 11, Col. Henderson sent them Captain HARDIN's North Carolina Company; but three days later not feeling justified in furnishing longer a guard for the Virginians, for which the state of Virginia should pay, withdrew Capt. Hardin's Company. The final decision of the North Carolina commission, which was forthwith carried into effect, was to run their line for a distance of 100 miles from the starting point, to the Cumberland Mountains.

The Virginia commission continued their line to Clear Fork, one of the headwaters of the Cumberland River, a distance of approximately 124 miles from Steep Rock Creek, reaching this destination on November 22. Here, because of many difficulties, as described in their official report, they discontinued the extension of the line; and thereafter made a wide detour, covering in time a period of more than three months, in very severe weather of this, the famous "hard winter" of 1779-1780. On Friday, February 25, 1780, they resumed the running of their line at a point supposed to be in latitude 36 degrees 30 minutes, located at two beech trees on the west bank of the Cumberland River. This point was estimated to be about 109 miles west of the Clear Fork, the western end of their former line. On March 23, they finished their line at the Tennessee River, just over 140 from the two beech trees above mentioned, where this lap of the line began.

After reaching Cumberland Gap, the North Carolina commission on November 17 drew up an elaborate report addressed to Gov. Caswell. In this report, they say:

"When all hopes of agreeing as to the true latitude were lost, and the partial line run by those (the Virginia) gentlemen carried on, with an express declaration of persisting in the measure, we thought ourselves bound to dismiss the escort, stop our proceeding and report the case to the general assembly. We wish to add, on this subject that we have the utmost confidence that the line run by us is as nearly in the latitude of 36 degrees and 30 minutes as 'tis possible to place it with the instruments in our possession, and that we have procured the best in our power; we have also at times had access to the quadrant made us of by the Virginians, by which as well as ours, we were confirmed in the opinion. The difference of two minutes and ten seconds of latitude in making observations with the same instruments cannot be accounted for."

After concluding the running of 100 miles of the line, Col. Richard Henderson, accompanied by his brothers, Samuel, Nathaniel and Pleasant, and a few others, continued the journey westward for the purpose of observing the Virginia commissioners continue their line to the Tennessee River. Col. Henderson's party, taking observations from time to time, reached Boonesborough, Kentucky, on Christmas day. After securing from the Virginia land commissioners warrants for valuable tracts of land and purchasing a large quantity of corn for the colony at the French Lick, Henderson's party set out for that place, arriving there in time to reassure and stabilize the infant colony. There Col. Henderson drew up the law for the settlers, some 250 in number, a famous document still preserved and known to history as the Cumberland Compact. Col. Henderson named the settlement Nashborough in honor of his friend Gen. Francis Nash, who had been killed at the Battle of Germantown, October 4, 1777. Eventually the name of the town was changed to Nashville. Many negotiations between the states involved, North Carolina, Virginia, Tennessee, and Kentucky, were entered upon before the dividing line was finally surveyed, agreed upon, and marked.

THEO. BUERBAUM'S BOOK STORE AND "LIBRARY"

Theo. BUERBAUM was born in Westphalia, Germany on September 2, 1852. He was the son of Joseph and Elizabeth Paas Buerbaum. His father, a college professor, passed his love of learning on to his son. He came to Salisbury as a young man and established himself well in his new community. On December 29, 1885, he married Jenny EAMES, a local girl, and they had four children, Elizabeth, Francis, Alfred, and Minnie.

The bookstore he established and operated for 46 years was very successful. Books were not the only product he sold. It was also possible to purchase china, crystal, wallpaper, toys, musical instruments, and pictures. Picture frames were also available, which Buerbaum made himself. And of course, the store sold post cards.

Buerbaum was active in his church, clubs, and civic organizations, and was a charter member of the Old Hickory Club, Salisbury's oldest social organization. He established, with Dr. F.J. MURDOCH, one of the first knitting mills. And along with Theo KLUTZ, he launched Chestnut Hill Cemetery, which they later sold to the city of Salisbury. From 1892 until 1900, Buerbaum and his father-in-law, Dr. E.M. Eames, published the *Salisbury Herald*, a weekly newspaper, which they later sold. He was also very interested in history and was one of the organizers of the Rowan Historical Society.

With a collection of 5,000 books set aside in his store, Buerbaum even established the first "library" in the city. In 1885, the membership fee was two dollars. He was considered a kind, honest, and generous man. He gave gifts of his time and love to his adopted community, and by most standards, these were generous gifts. But he gave much more. As an amateur photographer, he loved to photograph the scenes of Salisbury. His images captured the people, places, and events with amazing clarity. He took the best images and sent them back to a friend in Germany to have them turned into beautiful black and white or hand-tinted postcards, which he sold in his store. They were popular too – the pretty scenes and the real people and daily events – and included such scenes as buildings being constructed, trolley tracks, businesses in operation, and children in classrooms. Years later, people began to collect the images he so lovingly created, and there are several books and postcard collections that include many of his creations.

On the anniversary of his 50th year in Salisbury, January 30, 1926, Buerbaum took out an ad in the paper to commemorate the event and thanked the people of Salisbury for their friendship, wishing them peace and happiness.

Theo. Buerbaum died on February 1, 1926.

Early Landowners of Rowan County

Rowan Public Library, the Edith M. Clark History Room, and the Genealogical Society of Rowan County are proud to announce that the Early Landowners of Rowan County maps, along with the index, have been digitized and published to the History Room website as our newest digital collection.

In 1995, James W. "Bill" Kluttz published a set of 6 maps that indicated the earliest land purchases in the area of North Carolina we now identify as Rowan County. While Rowan County in 1753 covered a much greater area than its current acreage, the maps feature only the land plats in the area that is currently Rowan. *The Early Landowners of Rowan County, North Carolina* maps, also known as the Kluttz Maps, originated in the work done in 1950s by David Rendleman. In his research, Kluttz also included portions of western Rowan that had not been previously incorporated in any plat map studies. Listed on each map within the property lines are the deed book and page number of the earliest deed reference as well as the grantor, grantee, and date of the sale. There are 1,200 names within the grantor/grantee lists. The Kluttz maps are invaluable for genealogical research in this area. These maps are accessible online by entering the History and Genealogy section of the library website, then the Edith M. Clark History Room link, click on the drop down menu for "Collections" and select the Kluttz maps or the Kluttz map index to explore for specific surnames.

A set of 6 maps and the index to the map can be purchased through the Genealogical Society for \$35.00. Sets are also available for viewing or purchase at the Rowan Public Library History Room. The deed abstracts and deeds on microfilm may also be accessed in the History Room.
